## Pedestrian Access to Quex Questionnaire - Responses

The questionnaire results are summarised in the enclosed Appendix from Richard Steel.

There is much food for thought in the analysis, and it is clear that there is demand for significant improvement in the pedestrian access both within and outside the Village. However, Acol's village boundary goes through the northern end of the recreation field and the land beyond belongs to the Quex Park Estate and comes under the jurisdiction of Birchington Parish Council. Acol Parish Council can support any campaign but cannot be responsible for development outside the village. Kent Highways are only responsible for the tarmacked Road, but they may be able to help with advice on how we might take this forward, and the Parish Council may be able to facilitate this.

### BROADBAND UPDATE (FROM RICHARD STEEL)

One of our residents discovered that BT is now accepting orders for FTTP services and posted on our Facebook discussion group. As a result, Karen has ordered a service for installation on  $22^{nd}$  June.

I have heard nothing further from Openreach, and have written again to Broadband Kent as follows:

None of the FTTP providers on the link provided by Openreach at https://www.openreach.com/fibre-broadband/fttp-providers yet seem able to supply Acol addresses, and neither does Acol feature in the upcoming Fibre availability for suppliers at https://www.openreach.co.uk/cpportal/home. Whilst I am happy for BT customers and anyone else who may be content to contract with BT, this seems a breach of Openreach's service obligation in what is supposed to be an infrastructure supplier that's independent of BT and providing a level playing field for all providers.

Please would you check and confirm that my understanding is correct - in that Openreach is in breach of its service obligation? That being the case, can I assume that you will join me in registering a complaint to OFCOM?



#### COVID-19 VACCINATION PROGRAMME - UPDATE

Vaccination Clinics are continuing to be held at the Saga Centre in Westwood Cross and invitations are being sent out to all vulnerable and at-risk patients and, currently, all those aged over 35, and shortly those in younger age groups.

Currently we are receiving supplies of both the Oxford Astra Zenica and Pfizer vaccines, so if you have not yet received your first dose, or may have initially declined the vaccine, Please **BOOK NOW!**

We are continually receiving a large number of calls asking, "Have I got Covid because..." or "where can I get vaccinated?" and many other similar calls. During the w/c 22nd February we received 1148 calls and during w/c 10th May 1120 calls, averaging one call every 1.8 minutes! Please be patient and understanding and try to avoid peak times when calling the surgery. Thank you.
