#### Hello from Claire!

With biting wind whistling outside, the threat of snow (oh no, PLEASE not snow!) and still no news on when we can start out meetings again, it would be easy to think that things are all doom and gloom.



Not in the slightest!

With the approach of spring we can look forward to longer days, more sunshine, lambs in the fields, and the glorious plethora of spring flowers to brighten

our gardens and gladden our hearts.

So, it will be no surprise that Daffodils are the flower for March!

As anyone who has agonised over which class to enter their trumpet/wide cup/narcissus/jonquil in the Spring Show will know, there are so many varieties to choose from you could plant a different one every year and never have them all!

Daffodils may have been brought to Britain by the Romans, who believed the sap could heal wounds.

In fact, the sap contains sharp crystals of calcium oxalate, which acts as an irritant and discourages animals from eating them.

It also causes other flowers to wilt if they are in the same vase!

The origins of the names Daffodil, Narcissus, and Jonquil are quite interesting. Daffodil - us Brits in ages past preferred the imported Asphodel to our native Daffs, calling them 'bastard 'affodil'

Jonquil - comes from the Spanish 'jonquillo' (rush) referring to the rush-like leaves.

Narcissus - the very handsome Greek man, who won the heart of Echo and then rejected her, causing her to hide in a cave until she wasted away leaving only her voice. He looked upon his reflection

in a river and was so entranced he fell in and drowned and was turned into a flower.

Shakespeare also makes reference to this most beautiful, historic bloom in 'The Winter's Tale'



'When daffodils begin to peer,
With heigh, the doxy o'er the dale,
Why then comes in the sweet o' the year
For the red blood reigns in the winter's
pale'

Who would have thought that gardening could lead to a lesson in Greek mythology and Elizabethan literature!

## Cliddesden Primary School

It has been a very different half of the term at Cliddesden Primary School over the past six weeks. The school has remained open to children of critical workers and those deemed vulnerable. We have had between twenty and thirty percent of the children in school on a daily basis.

All the teachers and learning support assistants have continued to provide a safe and stimulating environment for the children of critical workers who have continued to attend school and also provided quality learning for the children at home. I cannot stress how demanding it has been for the teachers to manage and deliver 'blended learning' with children in the class and at home at the same time.

Using Google Classroom, the teachers have been able to provide high quality lessons and arrange daily 'meets' their

classes online. We have also been using technology to have fortnightly individual 'catch-ups' with every child at home and weekly assemblies and story time sessions.

We look forward to when all our children can return safely and know that there are many more challenges ahead. We will ensure that we support our children, as they return to a sense of 'normality', not just with 'quick fixes' but by supporting them socially and emotionally, as well as academically. Children are natural learners, and they are resilient. We have already seen how they can adapt well to changes and will continue to make good progress whether it is slower than normally expected or not. We know they will catch up quickly if they haven't already.

# Cliddesden Neighbourhood Plan Update February 2021

Your Neighbourhood Planning Team has been assessing the results of the 2020 Issues and Options Consultation and has produced a full report which can be seen on the CNP website and at:

https://cliddesdennp.wixsite.com/cliddesdennp/other-documents

A big thank you to everyone who completed a questionnaire, for without this input we would not have been able to move on to the next stage of the process. We received some 174 completed questionnaires which equates to approximately 39% of the residents of Cliddesden. This is an excellent result as many plans we have looked at only manage 20-25%.

The results of the consultation showed a very strong support for the options being put forward an example being:

"Development proposals must show how they would conserve or enhance the character of the plan area in line with Design Codes, Conservation area appraisal and Heritage Supplementary Planning Document." (Which received 98.3% approval.)

We also asked for additional written comments, and here the themes were:

The need to protect the environment, concerns over the volume of houses being built, traffic speed and volume, with particular references to traffic and parking on Farleigh Road. Concerns over the proposal for the "Swallick Garden Village", off street parking, flooding, and suggestions for adjustments to the proposed Local Green Spaces.

Managing expectations will be important as we move forward, a Neighbourhood Plan is mainly concerned with land use. Some of the comments received indicate that wishes may exceed what it is possible to deliver via a Neighbourhood Plan.

**Next steps:** The results overall show very strong support for most of the options presented. Consultation was an important step, and we will use this information to assist the formulation of policies that reflect the wishes of the majority of the village.

#### **Dear Residents**

I am pleased to report a reduction in reported crime in the area of this magazine, but wish to make you aware of some in a neighbouring parish. We had an attempt to break into a car parked in Bagmore Lane, Herriard between 4:30 pm January 28<sup>th</sup> and 12:00 on the 29<sup>th</sup>. We have also had a number plate stolen from two cars parked in Winslade lay-by whilst people out walking.

I also wish to reiterate yet again the requirements for dog owners to keep their dogs on leads when near farm livestock. I am currently dealing with three dog attacks on sheep resulting in seven ewes being killed, three others have aborted their lambs and one other which was severally bitten and is undergoing treatment. In one case a dog literally ran over 34 of a mile to get at a flock of sheep. Please be aware that farmers do have the right to shoot any dog found in the act of worrving livestock on agricultural land, it is vital that EVERY dog owner, and it can be any dog despite what most people say, that will chase sheep given the chance. Please keep your dog under proper control when in the countryside, most people will not even be aware that a flock of sheep could be in the next field out of sight.

Whilst I am pleased to report a lack of reported crime within the parishes of this magazine, one large problem we are experiencing nationwide is various scams. One recently was a resident in Ellisfield having a man stating he was from the Oxfordshire Police. Usual story - had a person in custody for fraud of the resident's bank card, can you confirm the details, etc. In this case ask for a contact number and say you will call 101 later today to be put back to them. DO NOT call anyone back at that time as they will keep their phone line open and you will end up speaking to the same group. If you can get a telephone number put it through Google as frequently it is known for scams.

Nearly a third of all fraud is committed over the telephone, Criminals can impersonate your bank, the police, tax office, investment or software companies and other trusted organisations. They will try to convince you to part with your money. Hang up on cold calls from any business/ authority, then 'Take Five' to check it out as genuine via a trusted source. The three most



common scams are: 1. Your computer has a problem - 2. A fraud investigation - 3. An investment opportunity.

Fraudster's tactics - Criminals can disguise their phone number to make it look like it's from a bank, the tax office, the police... or anyone. They can call you with what looks like a genuine phone number. They will keep your landline open by not hanging up and even play a dialling tone over the phone. They can text messages requesting you call them, or click on a link. These messages usually appear in the same text thread as genuine messages. And send website links which can steal your data and money when you click on them. Never trust the caller ID.

A computer problem - Criminals may call and claim that there are problems with your computer or internet. They claim to be your computer manufacturer, telephone or internet service provider and suggest they can help you. They instruct you to download a program which gives the criminal remote access to your computer. They can then access your bank. If you receive a call like this hang up. 'Take Five' and verify via a trusted method, not via numbers given in the call. Never allow anyone to remotely access your computer. Do not download software on the request of a phone caller. A genuine service provider will never call you out of the blue regarding issues with your computer. If you are having issues with your computer, contact the retailer you purchased it from.

If you are having problems with your internet connection, contact your internet provider.

<u>Fraud Investigation</u> - Your bank account has been compromised. Criminals may call and claim to be from your bank, the tax office or police and claim there is a problem with your

bank account. They often state there are corrupt staff at your bank, or criminals have cloned your bank cards and request your assistance with the investigation. If you receive a call like this hang up. 'Take Five' and verify via a trusted method, not via numbers given in the call. Your bank, the tax office or the police will never ask you to transfer or withdraw money or buy items on their behalf. Your bank, the tax office or the police will never attend your home to collect your cash, bank cards or ask for your pin. Speak to friends or family if you are unsure. Never share your PIN with anyone. Not even by tapping it into the keypad on your phone -If you receive a call like this hang up. 'Take Five' and verify via a trusted method, not via numbers given in the call. Never allow anyone to remotely access your computer. Do not download software on the request of a phone caller. A genuine service provider will never call you out of the blue regarding issues with your computer. If you are having issues with your computer, contact the retailer you purchased it from. If you are having problems with your internet connection, contact your internet provider. Genuine investment companies will not cold call you. Don't be pressured into making a guick decision and seek impartial financial advice before committing to any investment. There are no 'get rich quick' schemes. If it sounds too good to be true, it probably is. When investing with genuine companies research what you have been offered and the investment company. Speak to the Financial Conduct Authority if you have concerns. Call 0800 111 6768 or visit www.fca.org.uk. They will call you to persuade you to invest in all kinds of products, including diamonds, wine or art. They offer low risk and high rates of return, claiming it's a once in a lifetime opportunity and you'll have to act quickly. If you do invest, the criminals will often request further 'transport' and 'storage' costs. These investments do not exist.

Always report scams and fraud to Action Fraud, either online

at <a href="https://www.actionfraud.police.uk">www.actionfraud.police.uk</a> or by telephone on 0300 123 2040. Every report; Assists police investigations, provides intelligence, informs national alerts that protect all communities, disrupts criminals and reduces harm.

Contact police directly on 101 or 999 in an emergency. Forward any scam text messages to Ofcom on 7726 (free of charge). All major phone companies provide a call blocker service. This should help screen out most phone scams.

#### 5 THINGS TO LOOK OUT FOR ON A SCAM PHONE CALL

- 1. The caller doesn't give you time to think, tries to stop you speaking to a family member or friend or is insistent and makes you feel uncomfortable. 2. The caller asks you to transfer money to a new account. 3. They phone to ask for your 4-digit card PIN or your online banking password. Even if they ask you to give it to them by tapping into the telephone keypad rather than saying the numbers out loud, this is a scam. 4. They ask you to withdraw money to hand over to them for safe-keeping.
- 5. They may say that you are a victim of fraud and offer to send a courier to your home to collect your cash, PIN, payment card or cheque book. For more information please visit <a href="https://takefive-stopfraud.org.uk/advice/">https://takefive-stopfraud.org.uk/advice/</a>

This is just a brief guide on what to / not to do when someone calls you.

May I also thank the many residents who have called in reporting suspicious vehicles in our area, it really helps and allows me to update our intelligence unit with such sightings.



DRAINAGE AND FLOOD MITIGATION Thank you to the County Council and to Highways contractors who have cleared all the grips and gullies within the Parish and beyond – up to Northgate Lane and particulary the grips to soakaways on Farleigh Hill. Since the work has been completed there has not been prolonged heavy rain, but following what rain there has been, the drainage so far appears improved.

#### UPTON GREY WARNING TO DOG OWNERS

A dog walked in Upton Grey has died from Alabama Rot. The owner walked around The Hoddington Estate, The Dower House, field off Cemetery Lane and Weston Patrick.

It is important to act quickly with this disease, if you see any new lesions on your dog call your vet as soon as possible. It is thought to be picked up on paws and legs on muddy walks so always wash off the mud.

**POACHERS** I will say again that we are incredibly fortunate to have PC Reid as a dedicated rural beat officer – and also to have the Portsmouth Estate security (Dave) – both of whom do their utmost to deter, disrupt and (in PC Reid's case) detain poachers. Other areas of the south do not have such support from the police and suffer nightly from these armed criminals.

On the evening of 22nd February (Monday) I heard three gun shots from the area to the south east of the village at approximately 7.30pm. A quick message to the estate security confirmed that there were no legitimate pest controllers due to be working on the estate land. PC Reid was called and along with the security patrol made their way to the area to investigate. A silver Subaru Forrester made off heading towards Alton on the A339. This vehicle is linked to poaching.



**RISKS OF USING POISON FOR RODENT CONTROL** PC Reid will be looking into a resident's reports that cats within the village may have been poisoned over recent weeks. One possible cause may be secondary poisoning. This can occur when poison is used to control rats and other rodents. If a rat (or other animal) is killed by the poison there can be sufficient residual poison in their body that if another animal (such as a cat, dog, fox, bird of prey etc) eats the carcass, the poison can affect them as well.

Please be very careful when using poisons or when employing professional pest controllers to do so, and consider alternative methods of control that reduce the risks to non-target species. I am happy to discuss these in detail with anyone considering using poison.

**ANTI-SOCIAL BEHAVIOUR** I have been made aware of a potential issue of anti-social behaviour from small groups gathering in the village. PC Reid is now aware and will monitor the situation and will look to engage with any groups causing a nuisance. We regularly deal with similar issues around the school and Farleigh church and by doing so prevent them escalating into larger gathering points and attracting criminal activity.

**WHAT YOU CAN DO TO HELP** This is my regular plea to report anything suspicious and any criminal acts, no matter how small they may appear. If the police are not made aware they cannot intervene and small issues can quickly escalate into bigger and more serious problems. While the police may not be able to immediately respond to every issue, if enough reports are received, PC Reid can use them to justify requesting additional support to deal with patterns of crime (such as anti-social behaviour or poaching).
