Section 1, Assertion 4 has been incorrectly completed as 'Yes' whereas it should have been answered 'No' due to failure to publish the AGAR and Notice of Public Rights on their website prior to the commencement date of the inspection period. This is consistent with the internal auditor's 'No' response to Objective L.
