#### 1. Appointment of Chair

Cllr Crosbie was nominated, seconded, and duly elected as Chair of the Play Park committee.

#### 6. Inspection Report and site inspection (remedial items for action)

security.

- b. Minor concerns were raised as to cracks in the framework of the swings. It was agreed to request a contractor fill in the cracks and wood stain the framework.

- c. Turning of slates on Multi Play. It was agreed no further needed doing.
- d. It was noted that the paving under the picnic table was looking rather tired. All agreed to ask a contractor to tidy up the area.

Cllr Crosbie was happy to get a quote for items 8a, b, and d.

#### 9. General discussion period

It was seen that paint on the multi play needed a refresh. This was to be looked at next time.

It was noted that vegetation was ingressing from the riverside. Members cut back this area, so it was more accessible.

It was mooted that the bin was in an impractical position. It was agreed that DWP should be contacted with a view to locating the bin in a more suitable place.

It was suggested that the fencing needed to be replaced at some point. Members agreed that this was a good project for any future CIL receipts


