221. MINUTES

222. MEMBERS INTERESTS

No members interests noted.

223. POLICING AND COMMUNITY WARDEN REPORT

PCSO Forsyth attended with Acting Inspector Johnston from Margate Special Constabulary. Officers carried out speed checks in problem areas and have been active in Tothill Street and Monkton Road during the last few months. During their visits they have dealt with the following;

October 12 tickets for speeding

15 words of advice (speed but not excessive enough for a ticket)

2 drink driving offences - vehicle seized

November 18 tickets for speeding

42 words of advice

3 vehicles without insurance

December 22 tickets for speeding

23 words of advice 2 – vehicles seized

January 7 tickets for speeding

13 words of advice

90% of those stopped/ticketed were local residents. Acting Inspector Johnston further reported that there will be continued monitoring of these areas and welcomed suggestions for any additional areas that may be problematic. They will also attend the school during pick-up/drop off times of the day.

The Chairman thanked Acting Inspector Johnston for providing police presence in the village.

PCSO Forsyth reported as follows:

Recently toured the Ministry of Defence site at Manston that is being used by the Home Office for processing asylum-seekers. The site is being used as an over-spill for Dover and will provide short term (up to 72hr) accommodation for asylum seekers before they are moved to longer term accommodation. Asylum seekers will not be permitted to leave the site during their stay.

PCSO further reported as follows

Crimes of note:

• No reported crimes of note since 7th December 2021.

Anti-social behaviour;

- Officers attended an RTC on Tothill Street. Speed checks are being carried out in this area.
- Criminal damage reported at the train station. Dealt with by BTP.
- A couple of reports of anti-social behaviour with fireworks and push bikes being ridden dangerously.

Items of good work;

- Continued vigilance to elderly residents led, sadly, to the discovery of a deceased person in a property. Checking on our elderly and vulnerable residents by neighbours is to be encouraged.
- Fly-tipping incidents along the old service road were reported and cleared quickly. Some addresses were found, hopefully this may lead to a prosecution of the offenders.

Community Warden Karl Aylett reported as follows:

- Agreed that the village are very good at looking out for elderly/vulnerable neighbours.
- Attended the Men's Shed Project which is going well and was well attended
- May be required to cover a colleague who is on long-term sick leave.

224. COUNTY COUNCILLOR & DISTRICT COUNCILLORS REPORTS

Cllr Crow-Brown reported as follows;

- A28 Relief Road next stage has been approved subject to funding.
- Sent an email complimenting the quick response to repair a drain that had collapsed close to Coles Funeral Directors.
- 2433 Squadron Air Cadets have moved from Manston to Margate and are suffering with low attendance. This will be monitored and reported on over the next few months

Cllr Day asked Cllr Crow-Brown to commend TDC on clearing the dyke at along Foxborough Lane to help alleviate flooding.

Cllr Smith was not present but provided a report as follows;

- 50 trees from Thanet Biodiversity have been reserved for planting by Minster and are due to arrive in early February.
- Attended Decembers TDC Cabinet meeting and asked the Leader to consider a moratorium on all large housing developments, given that local infrastructure is inadequate to cope with the influx of homes and residents.
- TDC budges is due to balance helped by the New Homes Bonus. Awarded due to 320+ new build homes and 260 formerly empty homes brought back into use. A high performance team is addressing the issue in Thanet.

225. CHAIRMAN'S ANNOUNCEMENT

Cllr. Mrs Gimes thanked Mrs Quittenden and all who volunteered and helped coordinate the Christmas event, making it a real success. Thanks was also given to the Christmas tree group who put up the trees and lights throughout the village.

The Twinning Association wish to plant a Royal Oak in the village and place a plaque in recognition of the Platinum Jubilee.

A letter was written to Gladmans requesting a public engagement meeting in relation to the proposed development of the land East of Tothill Street. A reply was received rejecting this suggestion due to Covid issues. A further letter has been written by the Chairman to express that this is not acceptable.

226. REPORT OF THE CLERK

The Clerk reported that £1000 members grant had been approved by Cllr Crow Brown to go towards the lift at the new parish office. A grant of £500 was also approved by Cllr Wright for the Mens Shed Project.

The Chairman provided an update on arrangements. Cllr Quittenden is leading the formal celebrations on Thursday with the Beacon lighting. A family event will be held in the recreation ground from 12-6pm on Friday 3rd June with musical entertainment, bar and refreshments. Further details to come. Cllr Quittenden has details of potential funding streams for the activities. The beacon lighting on top of the Church will take place from 9-10pm on Thursday 2nd June and a Piper and Bugler will play. A Church celebration will take place at 12p on Sunday 4th June.

RESOLVED: To allocate up to £3000 to fund the event.

and (ii) that Council approves the draft budget as submitted and to request from TDC a Precept sum of £88,044 for the year 2022/23, this would give a DECREASE of £1.71 pence per annum which represents an annual charge of £67.59 pence or £1.30 pence per week on a Band D property or 2.46% decrease per annum on a band D property.
