1. Apologies for Absence

2. Declarations of Interest

3. Minutes of the Meeting of 26 October 2020

- 4.4 Review of the Effectiveness of the System of Internal Audit Cllrs Mrs Oxtoby and V Sewell carried out the review on 22 March 2021 and have recommended that no changes are necessary.
- 4.5 Audit It was NOTED that the Northfield Audit will be carried out on 22 May 2021.

5. Land and Site Maintenance

- 5.1 Quantified Tree Risk Assessment Quotes for the necessary tree work were considered and Cllr M Brown PROPOSED that the quotation from NPC Tree Surgery in the amount of £550.00 plus VAT is accepted. SECONDED: Cllr Mrs Oxtoby and AGREED.
- 5.2 Rural Payments Agency it was NOTED that the applications for the Basic Payments Scheme and the Countryside Mid-tier Stewardship for 2021 have been submitted, but following a mapping inspection amendment will need to be made as follows:

Countryside Stewardship

- The informal play area which is mown is not eligible for the Countryside Stewardship and 0.973ha will be deducted from this claim.
- The area of trees in the south east corner does not meet prescription P133 as this area is not cut for hay and therefore 0.2099ha and this will be deducted from the claim

Basic Payment Scheme

Bramble and scrub area in the south east corner amounting to 0.135ha and another 5 areas of scrub along the northern boundary with the footpath along the side of Pineleigh and along the northern boundary from the Church Road entrance, amounting to 0.1586ha will be deducted. It was NOTED that much of this scrub is blackthorn that will continually grow out into the field by up to 1m per year.

Cllr Mrs Oxtoby PROPOSED that the relevant claims are amended as above and that the blackthorn hedge alongside Pineleigh is maintained at its current depth. SECONDED: Cllr M Brown and AGREED.

- 5.3 Cllr Mrs Oxtoby PROPOSED that two benches are purchased and to be placed along the hedge in the play area at a cost of £459.40 each plus VAT and below ground anchoring systems in the amount of £42.24 each plus VAT SECONDED: Cllr D Graeme and AGREED.
- 5.4 Village Green it was felt that Northfield is self-protected in that the New Ash Green Village Association is not allowed to sell the land that it owns. Cllr Mrs Oxtoby PROPOSED that signs are purchased from Hartley Parish Council's provider to put at the entrances to Northfield saying, 'Northfield Open Space' SECONDED: Cllr M Brown and AGREED.
- 5.5 Matters arising from walk around Northfield
 - Three Ash trees in the neighbouring property of Hartley House or Byfields were identified in the QTRA as needing urgent attention and a letter will be sent to both properties.
 - There are a few branches in Barnetts Wood that need to be trimmed for the horse riding route.
 - The surface of the ground on both sides of the kissing gate entrances on public footpaths from Hartley to Northfield have been reported to Public Rights of Way.
 - Wildflower Meadow Cllr Mrs Oxtoby PROPOSED that this area is harrowed to encourage more growth at a cost of approximately £250.00 and that field will be rolled in early March 2022. SECONDED: Cllr M Brown and AGREED.

6. Horse Riding

It was NOTED that the horse riding route opened on 29 March 2021 with 11 members renewing their membership.
