22/23 Minutes:

The Town Council confirmed the minutes of the Annual Public Meeting of the Town Council held on the 30th May 2023 and the Annual Meeting of the Town Council held on the 30th May 2023 which were signed by the Chairman.

23/23 Matter arising from the Minutes:

No Matters arising from the minutes.

24/23 Chair's Items:

The Town Council noted the correspondence received from Mr J Crowe concerning the future provision of Shrewsbury A&E and Telford A&E without making any further comment.

The Chairman would complete the recent survey forwarded by the Police Commissioner.

25/23 Highway and Amenity Items:

- a) Craven Arms Playing Fields No items to report.
- b) Craven Arms Flooding Scheme No update to report.
- c) **Planters** The planters had been received from Shrewsbury Town Council and had been installed on the various streetlights.
- d) **Highways/Street Lighting** A meeting had been held with representatives of Highways England to discuss the condition and overgrown bushes in the planters bordering the highway adjacent to Drovers House Shrewsbury Road Craven Arms who agreed to tidy up the area and consider a future long term hard surface scheme to remove the existing bushes. The Town Council were unable to tidy the area because of Health and Safety provisions in undertaking required works with it being near the highway.

The Clerk to report the streetlight fault at Brook Road Craven Arms.

e) **Notice Boards/Seats** – Following a request from the Craven Arms Events Committee it was agreed that the Notice Board from outside Cyril Basons Shop could be installed in the old Market Centre at Drovers House.

It was agreed to install the seats being provided by the Fire Service on the small parcel of land at the junction of St Johns Crescent/Greenfields Road and in the Play Area Newington Way.

26/23 Financial Items:

The Clerk had produced and Income and Expenditure Statement which showed the Council had balances of £234,573.61 as at the 26th June 2023 following approval of the following accounts and a statement of balances held in the appropriate bank accounts to comply with the Councils investment policy.

The Town Council approved a grant payment of £2,600 to the Craven Arms Discovery Centre towards the Wetland Scheme this subject to planning approval and other funding being available.

The Town Council approved the grant of £2,000 towards the Tuesday Night Craven Arms Youth Club facilities being a condition of the grant of £5,178 received from the Shropshire Council Thriving and Families Fund.

The Town Council approved a grant of £100 to CACE as a contribution towards the annual insurance for litter picking in the town area.
