Description: In conjunction with the scheduled Warwickshire County Council alignment of the A46 Link Road Scheme, this application proposal seeks highway improvement works along a section of Stoneleigh Road. The highway works proposed includes the construction of a 4-arm roundabout to provide two additional access roads. One to access the proposed relocation of the Rugby Farmers' Market; The other to a HS2 46/Ashow Road Main Works Civils Contractors compound.

Cllrs would like the Clerk to write to Rob Young and ask what is likely to happen next with this application. There are suggestions within the HS2 community that the roundabout might not go ahead just yet and in the meantime a T junction might be provided. Cllr's are completely against this idea and need to urgently understand what the planning authority's response is likely to be to this application.

Cllr Bianco asked that the Parish Council push for the roundabout solution as this provides the perfect access for the Farmers Market, the New HS2 Compound extension and the proposed Stoneleigh Bypass.

Following a lengthy discussion it was agreed that the Parish would write to both County and District Councillors explaining what the Parish were looking for from the roundabout solution.

123. Stoneleigh Park Events

Cllr Hancox read out the two items of correspondence we had received regarding recent events at Stoneleigh Park. Cllrs requested that the Clerk should write to both, thanking them for taking the time to notify us of their concerns and that the Parish Council will continue to try and discuss residents' concerns with the team at Stoneleigh Events.

124. HS2 Update

Cllr Bianco talked about the new bridge to be provided on the B4115 not far from Crewe Lane. He had obtained a drawing that once again confused all present with regard to the provision of a footway/cycleway along the Ashow Road.

It was agreed Cllr Hancox would contact BBV and see if we could get some clarity on this issue.

125. South Warwickshire Local Plan

WDC Cllrs reported that there were two sessions being made available to discuss this topic. One was on the 14th December 2022 between 4pm and 5pm or a second session on the 15th December 2022 between 6pm and 7pm.

Cllrs Astle, Matthews, and Bianco said they would all attend the session on the 15th December 2022. The Clerk is to forward details of attendees to Cllrs Redford and Wright.

126. Neighbourhood Plan

Next meeting with Gary Kirk was noted as the 19th December 2022 at 7pm. The meeting would be via Zoom.

127. Crewe Lane Report

It was reported that County Cllr Tracey Drew is looking again at the situation in Crewe Lane, also there had been a very serious incident in Crewe Lane which resulted in the Air Ambulance having to air lift an injured party from the scene.

128. Community Speed Watch

Cllr Hancox reported that he and PCSO King are looking to organise refresher training for the Community Speed Watch volunteers sometime in the New Year, however it was noted that if the closure of the Birmingham Road goes ahead, the Community Speed Watch scheme may become redundant.

129. Masterplanning Framework for Land to the North and East of Kenilworth/South of Coventry

Cllrs thanked Cllr Pam Redford for arranging the first meeting of this new group. It was reported that the next meeting of the group would be the 4th January 2023 at the Town Hall in Leamington from 10am to 11am. Cllr Hancox said he was planning to attend and that there were two places available for each Parish Council.

130. A46 Stoneleigh Road Junction Improvement Scheme

It was reported that the old bridge over the A46 would be reopening just prior to Christmas on the 23rd December 2022.

Colas have decided not to move the new bridge into place until the weekend of the 16th January 2023 and will be doing so under a full weekend closure of the A46 and most likely the road over the top of the A46 as well.

131. Updates from Warwickshire Police, WCC Cllr Redford, WDC Cllrs P Redford and T WrightWarwickshire Police

A report was submitted by Warwickshire Police listing all the reported crimes in the area since the last report had been submitted.

Cllrs expressed surprise that the armed robbery at the post office in Cubbington had not made it on to the report. Cllr Hancox would check with the police why this was.

Warwickshire County Council Update - Cllr W Redford

Cllr Redford said he had kept the parish informed via email of anything new so nothing to report to the meeting.

Warwick District Council – Cllr P Redford & Cllr T Wright

Cllr Redford reminded the meeting that once again car parking would be free in town centres over Christmas. Cllr Wright reminded the meeting that this did not apply to on street parking.

132. Correspondence

There was no correspondence to consider.

133. Questions to Chairman

Cllr Redford asked if the Parish had identified any “Warm Hubs” yet? The meeting agreed that there were only two possible contenders, the Village Hall and the Village Club in Stoneleigh or the Village Club in Ashow. Cllr Hancox will contact all three and identify what each has planned. Cllr Redford also mentioned there was an offer of £300 towards the heating bills of any establishments offering the service, ideally it only needed to be once or twice a week.

Cllr Matthews asked what the latest was with the events being held on land near to the Chesford Grange. Clerk to email Cllrs P Redford and Wright for any updates.
