#### 2023.35 Environment

Fly-tipping remains a concern, however, it was considered that it had been quiet since the last meeting and there were no new issues to report.

## 2023.36 Highways

The poor condition of Field Lane and Grindle Road remain a concern, particularly the steady deterioration of Grindle Road.

Visibility on the junction of the A4169 and B4379 was raised as a matter to be actioned, although there has been a cut, some large thistles have been left and they are impeding visibility to the left. It was agreed that the Parish Clerk should report to the Highways authority this via Fix My Street.

#### 2023.37 Other Parish Matters

Cllr Mary Wright said that she had visited the Boundary Commission website to comment upon the boundary changes, but had found the layout off-putting and had not completed her filing. Cllr Phil Jones said that he had registered his comments. He had mentioned the increased number of Parish Councils that the Shropshire Councillor for the proposed Shifnal Rural ward would represent.

Speeding through the village remains an issue. A resident has noted to the Chairman (Cllr Phil Jones) the speed of some agricultural vehicles through the village.

Overgrowth on a local footpath is impeding use of a kissing gate. This was noted as an issue requiring action.
