### 76 APOLOGIES FOR ABSENCE

Councillor T Groves, due to a work commitment.

### 77 DECLARATIONS OF INTEREST

Councillor Mallory declared a personal interest in any matter arising on the agenda in relation to the Seamer Sports Association, as she was a representative on the Association.

Councillor Milner declared personal interests in any matter arising on the agenda in relation to the Friends of Seamer Village, as she was Secretary of the Group, and in relation the Linden Homes' housing development near Stoney Haggs Road and Beacon Road, as she lived in that area.

Councillor Raine declared a personal interest in any matter arising on the agenda in relation to the Friends of Seamer Village, as he was a member of the Group.

Councillor Smith declared a personal interest in any matter arising on the agenda in relation to the Crossgates Community Centre, as he was Chairman of the Association.

Councillor Stockdale declared a pecuniary interest in item 10 on the agenda [minute 85 (a)] in so far as it related to the existing refurbishment of public seats.

Councillor Wallis declared personal interests in any matter arising on the agenda in relation to Station Road, as she lived in that area, and in relation to the Crossgates Community Centre, as she was a representative on the Association.

Further to minute 57 of the last meeting, the Council considered a verbal report by the clerk that the Youth Club Management Committee had been requested to confirm its members' commitment to attendance at meetings and effective Parish Council representation, on or before 30 August 2019 for the next meeting of the Parish Council.

RESOLVED that this matter be deferred for consideration at the next meeting.

# 79 PUBLIC PARTICIPATION

The following matters were raised by members of the public and Councillor Jeffels, whose report was also considered and discussed:

- (a) a proposal to extend the duration of the road closure in Long Lane.
- (b) regular parking and the possible siting of an operating centre for heavy goods vehicles in a field.
- (c) a public notice by the County Council concerning a field to the south of Long Lane.
- (d) obstruction of a public right of way from Dunslow Road across a field (near to but not involving North Sea Winches) by an impassable blackthorn hedge.
- (e) an application made to the County Council to register a village green and an intention to submit an application for a public right of way, in the Rowan Fields area of Crossgates.
- (f) a request for additional speed restriction signs in Ratten Row.
- (g) further to minute 62 (iii) of the last meeting, awaited traffic calming on the B1261 at Crossgates.
- (h) further to minute 62 (iv) of the last meeting, a traffic management system for Station Road and Byward Drive.
- (i) further to minute 62 (v) of the last meeting, the installation of traffic lights at the crossroads of Pasture Lane and Stoney Haggs Road.
- (j) further to minute 62 (vii) of the last meeting, continued delay in the operation of the pedestrian crossing near Proudfoots.
- (k) removal of a post box from Pasture Lane at the end of Dennyson Avenue, and it not having been replaced following work by the Borough Council on light columns.

### RESOLVED that:

- (ii) further to minute 140 of the meeting held on 13 November 2018, Councillor Jeffels' offer to explore extending the closure of Long Lane to motor vehicles to July and August with the County Council, be accepted with thanks.
- (iii) Councillor Jeffels' offer to raise the parking and possible siting of an operating centre for heavy goods vehicles near 1 Ayton Road for investigation by the Borough Council, as the Planning Authority, be accepted with thanks, and the matter be explored also with the relevant regulatory authority.
- (iv) clarification be sought of the purpose and potential impacts of the public notice concerning the field to the south of Long Lane, for which Councillor Jeffels' offer to raise the matter in his forthcoming meeting with the County Council's Public Rights of Way Officer be accepted with thanks.
- (v) Councillor Jeffels' offer to raise the obstruction of the public right of way in Dunslow Road, in his forthcoming meeting with the County Council's Public Rights of Way Officer, be accepted with thanks.
- (vi) the application made to the County Council to register a village green and an intention to submit an application for a public right of way, in the Rowan Fields area of Crossgates, be noted.
- (vii) it be noted that the 30mph speed limit in Ratten Row is notified and enforceable with existing signage covering the village.
- (viii) the Council consider the County Council's proposals for traffic calming on the B1261, following the County Council's engineer's recommendations, noting Councillor Jeffels' suggestion that a scheme could be part funded through his County Council Locality Budget for environmental work.
- (ix) Councillor Jeffels' confirmation that he will ensure a further public meeting, as part of the consultation on a traffic management system for Station Road and Byward Drive, be accepted with thanks.
- (x) it be noted that traffic lights will be installed at the crossroads of Pasture Lane and Stoney Haggs Road by 31 March 2020.
- (xi) the Council receive further information on delay on the pedestrian crossing near Proudfoots, following Councillor Jeffels raising this matter with the County Council and receiving further information.
- (xii) Royal Mail be requested to replace the post box in Pasture Lane at the end of Dennyson Avenue as soon as possible.
- (xiii) Councillor Stockdale's offer to provide an existing litter bin and Seamer Sports Association's offer to install and manage it near the play area on the sports ground be accepted with thanks.

- (iii) it be noted the bins in Long Lane were emptied by the Borough Council following the road being re-opened and requests had been made of the Borough Council for: a number of bins in Pasture Lane; a 4<sup>th</sup> bin in Long Lane; maintenance to repair the gate to the hard court at the junction of Long Lane and Crab Lane, and patrols by Dog Wardens in the Pasture Lane, Long Lane and Crab Lane areas, which had commenced.
- (iv) the suitability of drainage to prevent run off from Linden Homes' Northfield Meadows development on to the Beacon Road area be clarified with Linden Homes and the Borough Council's Planning Services.
- (v) it be noted: concerns over anti-social behaviour in the brick built bus shelter on B1261 Cayton Low Rd opposite Station Road and criminal damage to the Parish Council's noticeboard in the brick built bus shelter on B1261 next to the junction with Station View had been raised with the Police; requests had been made to the Borough Council for more frequent cleaning of the bus shelter opposite Station Road and for a litter bin at the bus shelter opposite the Byways, and a request had been made to the County Council to identify ownership and responsibility for the bus shelter opposite the Byways, in order to be able to address the structure and presentation of the shelter itself.
- (vi) the Borough Council had been requested to confirm responsibility for various overhanging trees and bushes in the Crossgates area, and the earliest possible timescale for the necessary maintenance to be completed, be noted, and the Parish Council's concern at the inadequacy of routine maintenance be expressed to the Borough Council, with a request for a meeting with Councillor White to address the wider issue.
- (vii) damage to a fence at the junction of Long Lane and Crab Lane be explored.
- (viii) Beyond Housing be requested to ensure the cutting back and future maintenance or removal of overgrown hedges, and repair the fence, on the Bell Close side of the approach road to the Sports Club.
- (ix) Councillor Stockdale consider making a personal response to the Borough Council's Draft Tennis Strategy consultation.
- (x) no response be made to the Borough Council's Affordable Housing SPD Update 2019 consultation.

- (iv) the invitation to the other manufacturer's trade show exhibition be declined.
- (v) to consider the Royal Society for the Prevention of Accidents (RoSPA)'s response to the learning point at the next meeting.
- (vi) not to undertake a review of all play areas and equipment.
- (vii) to consider the Royal Society for the Prevention of Accidents (RoSPA)'s inspection reports, as soon as possible following them being made available.
