4. Minutes of the Previous Meeting:

The minutes of the meeting held on the 11th January 2010 were agreed and signed by the Chairman as a correct record.

5. Planning Applications:

a) Planning Application 10/00489/Full – Steventon House Steventon Road Ludlow – erection of Photo Voltaic panels on south facing roof of dwelling – Steventon House Steventon Road Ludlow – No Objection in principle but concerned about the prominence, design and positioning of the panels.

b) The Parish Council considered the Final Core Strategy Plan produced by Shropshire Council. The Strategy sets out the strategic planning policy for the whole of Shropshire including a spatial vision and objectives. It also sets out a development strategy, which identifies the level of development expected to take place within Shropshire up until 2026 and a number of Core Policies, which help to achieve the vision. The major development is focussed in the main market towns of Shropshire.

The Parish Council agreed to submit a representation in respect of the plan. The core strategy highlights the types of development but makes little reference to the required infrastructure needed to support those developments. Recent developments in Ludford, the Eco Park and the affordable Housing site are seen as piece meal development without considering, for example, the impact on transport and road users.

The Clerk was asked to obtain details of housing developments undertaken in the Ludlow/Ludford area since 2006 and where planning approval has been granted for future development.

The next document to be issued by Shropshire Council will be Site Allocations and Management of Developments Documents the implications of which will be considered at a meeting to be held on Monday 26th April 2010.

6. Highway Items:

- a) The Clerk reported that the road safety mirror at the junction of Lower Barns Road/Overton Road, Ludford had been installed by Shropshire Council.
- b) The Parish Council agreed to request the installation of a litter bin at the entrance to Foldgate Lane, Ludlow and to approach Harry Tuffins for a contribution towards the cost of the works.
- c) The Clerk reported that Shropshire Council will install a Bus Stop flag at the junction of Ledwyche Court and in Beaconsfield Park in respect of the new Ludlow town Bus Service.

- d) The Clerk to make a further request for a dropped kerb on the footpath opposite the entrance to the Eco-Park the Sheet Ludlow.
- e) The Clerk to enquire when the road surface work is to be undertaken in Foldgate Lane and the temporary road surface signs removed.
