# **b.** Athletics Track Application

councillors. A letter has also been received from Mr N. Weiss, the landowner, and this was read out to the meeting. His letter will be acknowledged and its contents noted.

# (i)Lafarge Application

C.Cllr David Watson was invited to speak. He reported that he is trying to get the extension application brought to the Planning Committee but at present it is due to be decided by delegated powers..

# (ii)Westhorpe Bund

The importing of earth requires planning permission from BCC. Far more material than needed has been imported and the County Enforcement Officer, has issued a stop notice. A planning application has not yet been submitted and a time limit for this of 10 days from today's date was given. If this is not received, then an Enforcement notice will be issued. The pile of materials at Westhorpe Farm is also subject to an Enforcement notice. BCC's Enforcement officer needs to be kept informed of any untoward activities at the site.

#### (iii)Winery

Cllr D. Watson understood that this may come before the planning committee meeting at WDC in November.

## a. Size of Cremated Remains Plots

BCC will monitor speeds and look into this further, including improved road markings.

The condition of the C100 verges were also raised. BCC will look into this further and will liaise with the Marlow LAF and Marlow Bottom Parish Council.
