# CHIDEOCK PARISH COUNCIL

Minutes of the Annual Parish Council Meeting held at the Village Hall, Chideock on Monday 26 June 2017 at 7 pm.

The Parish Council meeting commenced at 7.00 pm.

Present: Cllr Roger Carey (Chair), Cllr Rob Murray, Cllr David Rogers, Cllr Peter Hunt, Cllr Irena

Campion and Cllr Kate Geraghty.

**In attendance:** The Clerk and 10 members of the public, DCC Cllr Daryl Turner and WDDC Cllr Simon Christopher, who arrived during the meeting.

Cllr Rogers and Cllr Carey had both signed the Declaration of Acceptance of Office forms in the presence of the Clerk since the last meeting.

# 1995 Apologies.

Cllr Laurie Elliot sent his apologies, which were accepted.

### 1996 Grants of Dispensations.

None.

# 1997 Declarations of Defined Pecuniary Interests.

Cllr Rogers declared an interest in planning application WAD/D/17/001212 WELL COTTAGE as the applicants are personal friends. He said that he would take no part in the discussion on this application.

#### 1998 Minutes.

a) RESOLVED to accept and sign, as a true record, the minutes of the Parish Council meeting of 22 May 2017.

Proposed by Cllr Rogers, seconded by Cllr Hunt, carried unanimously.

### 1999 County and District Councillors' and Police Reports.

Cllr Turner reported as follows: -

- The DCLG decision regarding 2 Unitary Authorities for Dorset may be made earlier than September.
- The new Bridport Connect social care hub is estimated to cost £6.1 million DCC it is looking for ways to reduce the cost
- Bus Service 40 Bridport to Yeovil Amory will stop running this in July. First
  Bus have said they will run a service between Bridport and Beaminster only.
  DCC have said they will run a service between Bridport and Yeovil to the
  current timetable, apart from the Saturday service which will not run, until
  September. DCC are in talks with First Bus regarding the service after
  September.

Standing Orders were suspended for the following item.

#### 2000 Democratic Period.

A member of the public read a statement regarding concerning a possible Parish Poll commissioned by the Parish Council on an A35 Bypass route, asking if the poll would consider all possible routes. The Clerk explained that a Parish Poll must be requested by electors via a Parish Meeting called by electors, that only a Yes / No question can be asked and that the question must be agreed at the Parish Meeting.

Members of the A35 Bypass Working Group reported on their recent meeting with Sir Oliver Letwin MP and said that Oliver had suggested that the next step would be to hold a Parish Poll and that he would meet with the Parish Council about this.

The Clerk confirmed that councillors had meet with Oliver.

The Chair said that councillors intend to meet informally to discuss the matter prior to the July Parish Council meeting.

A member of the A35 Bypass Working Group asked if members of the public could attend this meeting. When informed that it was a "private" meeting he said that he did not consider that to be democratic or transparent. The Clerk said that any decision on the matter would be made at a full Parish Council meeting and that the purpose of the informal meeting was to prevent unnecessary time being taken at a Parish Council meeting on discussions around this important matter.

A member of the group said that they had been told that a poll could be held soon so that the matter could be taken to Highways England in time for the Route Strategy decision in November.

2 members of the public said that they did not consider that the results of the recent survey carried out by the A35 Bypass Working Group demonstrate a consensus for the suggested northern route.

A member of the public spoke about Chideock Air Quality and said that in his opinion the only solution was a "relief" road. He asked what response CPC had made to the recent government Air Quality consultation. The Clerk said that they had not known of its existence until after the closing date.

A member of the public asked if a poll would include the neighbouring parishes (Char Valley and Symondsbury), both of which would be affected by a bypass. Cllr Carey said that Oliver Letwin had said that he would take care of that if a poll showed a consensus for a bypass.

Standing Orders were resumed.
Cllr Christopher arrived during the previous item.

### 2001 County and District Councillors' and Police Reports continued

Cllr Christopher reported as follows: -

 He shares the concerns of residents and the Parish Council regarding air pollution and has met with Ashley Fox MEP and talked to Oliver Letwin on this matter, especially regarding a bypass

- He suggested that CPC also contacts Julie Girling South West MEP
- At a recent Tri-Council Partnership meeting it was stated that all 3 councils are failing to provide adequate numbers of "affordable" housing units
- The Planning Committee is currently meeting 2 times a month the Bridport St Michaels Trading Estate application will come before the committee on 6 July
- WDDC is financially healthy
- He suggested that Martin Underhill, Dorset Police and Crime Commissioner, be invited to attend a meeting in Chideock to talk about the lack of police in rural Dorset

**Item 19A – Quarr Cross Cross Road Signage Obscured by Vegetation. AGREED** to ask Symondsbury PC for help in gaining the land owner's permission for Connect to cut back the vegetation.

**Item 22B – Speed Camera Replacement. AGREED** to write to Highways England urging them to provide funding towards the cost of Average Speed Cameras. **AGREED** to follow up with Dorset Road Safe after their meeting with HE on 7 July.

Additional item – Junction of Eype Down Lane with A35 at Quarr Cross - AGREED to ask DCC Highways to investigate the possibility of prohibiting vehicles from exiting from Eype Down Lane onto the A35.
