Oulton Parish Council (OPC) note the ExA have already visited Oulton at the River Bure. However OPC would like to suggest the following locations in Oulton to be included in the ASI 2.

Two properties at the HDD site of SEP/DEP cable route under the Solar Farm Site (not yet constructed).

Areas of concern are *Noise & Vibration* (APP-133) CCR16B / CCR16C (see figure 1) Access issues for Bluestone Cottage at (APP-014) ACC25b.

As well as the temporary 'Stopped up Streets' The Street. Oulton LINK 131.

(APP-015) 16g-16h / 16k-16l given that this road is also used as <u>the only access route</u> to Main Construction Compounds for both Orsted and Vattenfall see (*figure 2 below)

Vattenfall

Mobilisation Area 7 = One of the largest construction compounds located along Vattenfall's cable route, this will serve a longer section of the cable route during the cable trenching and ducting works.

Cable Logistics Area: *since* consent of their DCOs, Vattenfall now refer to this as their Central Works Compound, will house offices, materials and cable drums.




figure 3:- **Docking Farm Solar site map** (Broadland District Council (BDC) 20211249/20211288)



B1149 Access

OPC would also suggest the ExA visit the access points along B1149.

The concern is the B1149 will be used by HP3/Vattenfall as well as agricultural vehicles. The road has hidden dips which are not sign posted, local observations have seen inappropriate overtaking, this has been due to misreading a clear road ahead only to find a car emerging from a dip.





figure 4 (APP-014) ACEW41






figure 5 Accident data B1149 ref: Orsted CTMP (Broadland District Council 20221810)
