## 139/2122 PRESENT & APOLOGIES FOR ABSENCE

  - Cllr. Arthur declared a potential perceived bias in relation to application 22/00227/FUL, as he previously owned the land.

## 141/2122 PUBLIC PARTICIPATION SESSION

Planning application 22/00227/FUL was summarised – it will be the same footprint and size as previously permitted but rather than re-using the original oak frame it will be clad with oak on the outside.

142/2122 **MINUTES** – it was **RESOLVED** to confirm the minutes of the Council Meeting dated 1<sup>st</sup> February 2022 as being a correct record and the chairman was duly authorised to sign them

# 143/2122 **REPORTS**

- *a)* Police Report the police officer had been invited but was unable to attend. He had reported that crime in the area is very low.
- b) Shropshire Council Cllr. Potter circulated a breakdown of Council Tax for this year and made the following points:
  - *Adult and children's social care* high proportion of costs.
  - Reserves used to subsidise council tax but can't happen next year as no reserves
  - Levelling Up will need to work in partnership with neighbouring authorities.
  - *NWRR* Shropshire Star ran a story re a letter about the road. It appears letter hadn't come officially from DfT. Business case has already been agreed. Environment Agency and Natural England are outstanding hurdles.
  - Local Plan heading towards public hearing stage, unlikely to be any challenge in Nesscliffe.
  - Broadband rollout current position needs to be checked with Connecting Shropshire
- c) Youth Club Cllr. Gilbert reported that the club is getting a few new members from surrounding areas. She asked if the club could use £125 for coach travel and it was confirmed this amount is available in the account and a BACS invoice will be sent to the club from Birch Travel.
- d) Great Mess to Little Mess
  - 15 trees from Woodland Trust plus trees from local residents

- 22 litter bags collected.
- Raffle made £48.
- Grant for £500 for new equipment achieved. A few people had expressed an interest in borrowing kits.
- Grant applications for benches / bins at the playing field/community land unsuccessful.
- Waste oil has been found at the VOSA site
- e) CIL Working Group the group has been managing the tender process for the play area and quotes for outdoor gym equipment.

 Proposal: Insertion of window into ground floor toilet affecting a Grade II Listed Building

2) 22/00227/FUL - Church House Barn, Church House Farm, Little Ness, SY4 2LG Proposal: Application under Section 73A of the Town And Country Planning Act 1990 for the part retrospective application for the rebuilding of a collapsed listed agricultural building to form a single dwelling to include the erection of a single storey link to an existing former pig pen/cowhouse to be converted to provide living accommodation, erection of a detached double garage and construction of new vehicular access and driveway replicating earlier implemented planning permission SA/02/1110/F Comments: It was RESOLVED to support the application and noted that it is positive to see this derelict site rebuilt and complementing the existing farmhouse.

# 146/2122 PARISH MATTERS

- a) Highways maintenance. Incl. EMG works a quote is being sought from Graham Taylor with a view to clearing the remaining pavements in 2022/3, when more EMG is received. to quote. It was also agreed to enquire again about the lack of pavement on phase1 and 2 of Hopton Park.
- b) Noticeboard at bus shelter Matt Morris of Shrewsbury Homes felt the oak board quote from a specialist company was too high and had suggested an aluminium board but there were concerns re design and durability. It was agreed to invite Nick Mullis to give a further quote for an oak board.
- c) Jubilee paper from Cllr. Dickinson the paper was noted and Cllr. Dickinson and Cllr. Gilbert offered to attend a meeting on 15<sup>th</sup> March, 7.30pm at Nesscliffe Village Hall to discuss this further. It was <u>RESOLVED</u> to set aside up to £700 towards projects, from the Parish Plan and Heritage Grant reserves.
- d) Request to plant tree at The Crescent and offer of bird boxes it was agreed that the bird boxes be managed by Great Mess and Little Mess. A suggestion of a cherry tree at an area of ground on The Crescent had been received; it was noted that this would usually need SC Highways permission but there is precedent as there was a tree there.
  - William Gilbert had 2 oak tree saplings to donate which Cllr. Dickinson offered to collect. It was suggested that when the play area is re-done, there will be a grand opening which will include tree planting.
- e) Slurry from manure heap at Wilcott/Kinton junction Cllr. Diggory offered to speak to the landowner.

- f) Tree survey Nesscliffe and Wilcott and emergency action taken- it was <u>RESOLVED</u> to remove the cherry trees at Wilcott and the emergency tree works at Nesscliffe were retrospectively authorised.
- g) S50 works progress update and repairs to VAS work underway, permits for crossing and removal of concrete columns at Wilcott being obtained by contractor.
- h) Reports of other parish matters
  - Resident not happy with the new board at Kinton. It was confirmed the old boards are being removed.
  - The Crescent sign is standing up on a tree and the one by the school both loose signs to be reported.
  - Fingerpost Little Ness to Ruyton XI Towns is on the ground needs reporting.

The total project budget is up to £90,000 plus VAT, with £45,000 to be funded from CIL Local balance from CIL NF and VAT to be reclaimed. The following points were noted and delegated to the clerk to action, with the Working Group

- Quote to be sought for path from MUGA to be extended to the outdoor fitness equipment area.
- Grass mats to be used apart from around roundabout where wet pour will be used.
- Fireman's Tower to be substituted for an alternative item which the school children will have a vote on.
