The meeting of the Parish Council was held on Tuesday 7<sup>th</sup> July 2020  
Via Zoom at 8.00pm.

**3.** The minutes of the meeting on 3<sup>rd</sup> March 2020: The minutes were approved and signed as a true record of proceedings.

**4. Matters Arising from 3<sup>rd</sup> March 2020**

**a) Report No. 123 of the Egerton Footpaths Representative – July 2020**

Pat had continued to produce reports for April, May and June but no meetings had been held by EPC.

**b) Highways: Report No. 11 July 2020**

**New:** Tim noted that there is a very big pot hole on New Road. John will report.

**Action:** John Lawton

Lois noted that her neighbour had received a letter of instruction from KCC to clear the drains on her property. Lois wrote a letter of complaint to Highways but has received no response. Richard suggested that Lois contact Charlie Simkins. John has already done this.

**c) Older people's accommodation:** Problems with arranging access continue, although Gary Reeve-Wing is now in direct contact with the New Road site developers and the owner of an alternative access option. Our solicitors recommended we appoint Vicky Phillips of Hobbs Parker to undertake valuation and other chartered surveyor consultancy work, which had been agreed between members by email. In place of the now redundant Heads of Terms Gary Reeve-Wing requested we jointly sign a 'Letter of Intent'. The Working Group asked Andrew Doinik of Halletts to redraft Gary's original proposal for this, and, having been circulated to and agreed by members, this has been signed by Heather and sent to Gary. Richard has circulated a more detailed Confidential note about these developments to members. The Working Group has met twice since our March meeting and will update members privately as things progress. **Action:** Richard King, Clerk

- d) **Extension to Games Barn:** This is on hold at this time. Bill has decided the time has come to step down from taking the bookings and invoicing of users of the Games Barn Thank you Bill and Joan for all your hard work over the years, you will be sadly missed. The Clerk has requested that an advert for a new booking Clerk be placed in the next Update magazine.

- e) **VE Day Celebration 75 Years:** Due to Coronavirus this event was cancelled. It is hoped that an event can take place out-doors on 15<sup>th</sup> August to celebrate VJ day. The working group are to have a meeting at some point in July which Claire will attend and update EPC at the August meeting.

- f) **Red phone box, Stonebridge Green:** There are now shelves in the phone box with too many books being left so the shelves are over-flowing. Lois has offered to go and sort and take away excess books and store them ready for the fete.

- g) **Trees in recreation ground and others to maybe be felled:** Prior to lock down the Clerk had contacted Aaron Pack but he was very busy. The Clerk will contact him again. **Action:** Clerk
- h) **GDPR:** Information audit forms have been received from all clubs, John will document.

- i) **Steps:** The 14 anti-slip plates purchased have been fitted. Sarah thought there needed to be more fitted. Following discussions it was agreed that some more plates should be purchased. The Clerk will look into this.

- j) **CCTV in car park-Police Forum:** Peter is following up on this. **Action:** Peter Rawlinson
- k) **Garden Community Proposal:** John reported
- 1) 3 of 8 landowners have withdrawn. This represents a small loss of available land for houses but significantly it also means the motorway junction cannot be built as proposed as the land required is no longer available.
  - 2) A significant part of the proposed development area has been given permission for mineral extraction. This effectively puts this land out of scope for development for 10-20 years.
  - 3) The effect of both of the above is to reduce the scale of the development to perhaps as little as 2000 houses until the quarried land becomes available
  - 4) Requirements for a motorway junction include a minimum of 10,000 houses and 10,000 jobs. For the reasons above and other MBC/Lenham Heath cannot deliver that requirement.
  - 5) MBC argued for continuation of the project and the further spend to the P&R committee on the basis of some discussions with ABC planners to join together and between them provide the meet requirements for a motorway junction which would be sited elsewhere along the transport corridor, closer to Ashford and in the Ashford borough.
  - 6) The Lenham Heath landowner situation is complicated with 2 of the 5 remaining being family trusts and transacting with them is not as straightforward as with others. It is also the case that the commercial proposition for the landowners does not look very attractive, with part payments up

front but most being paid over a couple of decades and contingent on successful sales. This seems to leave landowners with quite a lot of the risk.

Despite the above MBC Planning and Resources Committee have approved an additional spend of £100,000, taking the total to £300,000 for further work on the plan for the Lenham Heath Development. The meeting was held over the internet and public attendance was possible although no public participation was allowed. MBC stated that public participation was not feasible, this is despite other Local Authorities conducting meetings over the internet with full public participation.

Part of MBC Planning Dept justification for the additional spend was predicated on communication with Ashford Borough Council about working together on a project which produces enough jobs and houses to qualify for a motorway junction. John Lawton made enquiries in this regard with ABC planners via our Borough Councillor Ken Mullholland with the following response.

*Just to let you know that officers here are in the process of arranging another discussion with our opposite numbers at Maidstone BC. In advance of that, I understand that MBC's original proposals as set out in their submission for the MBC 'call for sites' exercise were regarded as being unlikely to be of a sufficient scale to be able to justify the delivery of a new M20 junction in the Lenham area, and so they are reconsidering what alternative approaches they might want to pursue.*

*Like you, I have seen various media reports attributing references from MBC Councillors to 'liaison' with ABC but I can assure that there has been no formal (or, as far as I know, informal) contact on this matter with either officers or members here. Certainly any references to large scale development on our side of the border should be regarded as wholly speculative at this point. When we know a bit more about the timescale and process for Maidstone's Local Plan from their officers, we'll keep you in the loop.*

John will continue to follow up on this item.

- l) **Speed humps and white lines:** Following the request for white painted lines to be placed on the speed humps leading to the car park and lines to show path kerb edges this work has been completed.
- m). **Mole Hills on recreation ground:** The Clerk requested Kilby's pest control to deal with this problem and received a quote of £90 which Cllrs agreed to. The Clerk will check with Kilby's if the problem has now been resolved.

- n) **Spring Clean:** Sarah had to self isolate early March so continued organising the Spring Clean remotely. Sarah expressed heartfelt and grateful thanks to Peter for taking up the task of organising litter pickers on the day.

- o) **Playground equipment:** Claire was to have a table at the Parish Assembly for villagers to have a say in what might be purchased but the Parish Assembly was cancelled due to Coronavirus.
- p). **Mowing:** Aspire have taken over from Heber Horticultural. Some members of the cricket club are not happy with the work that is being carried out. The Clerk has been liaising between Aspire and the cricket club committee. The Clerk will suggest a meeting between the various parties.

- q). **New notice board:** This has been erected onto the wall of the Computer Centre.
- r). **Parish Assembly:** To be held on Thursday March 19<sup>th</sup> in the Millennium hall. Due to Coronavirus lock down this event was cancelled.
5. **PCSO:** A report has been received this month.
6. **Neighbourhood Plan Update:** Report by Jane Carr  
The extended date for return of comments and questionnaires on the draft Reg 14 Plan is 10<sup>th</sup> June. So far 31 questionnaires have been returned, as well as 2 responses from developers and 3 emailed comments on specific aspects of the plan. The responses have been broadly supportive of the plan, although considerable concern has been expressed about existing failings in utilities provision (specifically water, electricity, sewerage) as well as speeding and congestion on village lanes. After discussion, it was agreed that the date should not be extended for a further period but that responses received after the 10<sup>th</sup> would be accepted. The 51 questionnaires and verbal comments from the November public meeting will also be taken into consideration. Although referenda will not now take place until 6<sup>th</sup> May 2021, the Ministry of Housing, Communities and Local Government advise that 'neighbourhood plans awaiting referendums can be given significant weight in decision-making'. It was therefore agreed that the NP Steering Group should go ahead with any re-drafting and report to EPC by September with a view to sending the re-drafted plan to Ashford Borough Council later in September for the formal 6 week consultation, and subsequent Examination.  
John put forward a request that councillors vote as to whether they were for or against development of the North Field Site.  
5 councillors voted against development  
3 councillors wanted further information from the developers before forming a view  
John unable to vote as has an interest  
Lois will draft a letter from the PC to ABC to say that the Parish Council would not support a planning application to develop houses on the North Field site at this time. **Action:** Lois Tilden
7. **Sale of shop:** Richard reported that after the public meeting the proposed purchasers of the Village Stores withdrew at the last minute early in March, and the shop was put back on the market. The couple previously interested also withdrew, but a third party got in touch with the parish council in early April and appear to be serious. They have been in contact ever since. They have visited the shop twice and in their last email confirmed their continuing interest. Fundamental criteria for them moving forward would be being able to re-instate the post office facility and we've put them in touch with Sam Coe at the Post Office who in May emailed that the PO would be happy to put a Local Post Office into the shop rather than a part time outreach. Hopefully they'll make an offer.

Meanwhile the pop-up Post Office in the Computer Centre, to be run by Alan Knight, the Postmaster at Headcorn, should open for business next Friday, initially using a dedicated mobile phone connection, although a dedicated landline will be installed on Thursday. It will be open for two hours two days a week. The days will be Tuesdays (we have asked for 3 to 5pm) and Friday afternoons to coincide with the Farmers Market. Heather is dealing with the detail.

8. **Response to Coronavirus:** Pat reported that the emergency plan which was in place worked well. There was a very good response from volunteers helping out in many different ways. Richard asked Peter to put an article in the next Update magazine. **Action:** Peter Rawlinson

9. **Barrow House:** When the pub was The George an Asset of Community Value was set on the pub. This remains in place until October 2020. It was agreed that we should re-apply to have the Barrow House listed as an asset of community value after the current designation expires in October, the Clerk will find out how to do this

10. **Approve revised Risk Assessment, Statement of Internal Control (SIC), Governance and accountability:** As this is the first meeting since March there is a lot of business, this item will be discussed at the August meeting. The Clerk will circulate all paperwork prior to the meeting.

11. **Risk Assessments and maintenance:** Sarah requested that once she and Claire had carried out risk assessments that any work that needed to be carried out could be discussed with the Clerk and the maintenance team. It was decided following discussions that the present system would continue. Any works that could not be carried out by the maintenance team and needed to be carried out by others the Clerk would organise a quote for the work and the Council would decide if the work should be carried out.

1. **PROW981700 and 599699.** (John Bunyard). Reported 14<sup>th</sup> August. AW64 Opposite Egerton House, right hand side of large field. Dangerous stile sloping down steep hill. Still *“Work Scheduled”*.
