## Change of use of barn to registered nursery and external operations Buildings At Manor Farm, Braybrooke Road, Arthingworth

The Parish Council strongly object to this application for the following reasons:-

- 1) It appears to be part of a haphazard development with a variety of applications and no masterplan.
- 2) It is not appropriate for the location.
- 3) It is outside the confines of the village and within the curtilage of a long standing active agricultural setting.
- 4) There is already an established children's day nursery within very close proximity and Cllrs. feel very strongly that the village cannot sustain two such establishments.
- 5) There will be a significant impact to the village with the increase in traffic
- 6) There are serious concerns regarding the access as the single track road is in a poor condition with no passing places.
- 7) The plan of the site shows 8 car parking spaces (the application form refers to 9), however the transport assessment estimates 204 vehicle movements per day. On the basis the nursery will have staff taking up a number of the 8/9 parking spaces, we have grave concerns as to where the remaining (from the 204 movements) cars will park.

#### DA/2017/1198

New roadway, car parking areas and bike shelter to serve development on adjacent site.

#### Land At Manor Farm, Braybrooke Road, Arthingworth

The Parish Council strongly object to this application for the following reasons:-

- 1) Braybrooke Road is a single track road which is in poor condition with no passing places. Cllrs. feel very strongly that it is not able to sustain the increase in traffic.
- 2) The bike shelter is totally out of character in the rural setting.
- 3) The bike shelter would appear to be quite unnecessary considering the location of the site and the proposed activities.
- 4) The application form refers to 17 car parking spaces however the transport assessment is not able to confirm what use these spaces might be serving. The application is clear that the proposal would be for the benefit of Barn C on the accompanying plan (despite this barn not having a planning permission) but is not able to state what that is. The transport assessment does confirm that if the barn was used for employment uses then there would be an estimated 18 departures in the single hour of 17.00 18.00 (Table 3, P5). Clearly 17 spaces will not be enough for 18 departing cars and this is before factoring in other movements outside of this single hour window.

The Parish Council are concerned and confused as to what these car parking spaces will be servicing and therefore why they are required and if they are adequate.

#### DA/2017/0442

Stationing of three additional residential mobile homes, re-siting of existing residential mobile homes cumulatively approved by virtue of planning permissions DA/2015/0083 and DA/2009/0095, and reconstruction and re-siting of a stable building approved by virtue of planning permission DA/201/0083, all for the purposes of a family traveller site (retrospective).

Golden Stables, Braybrooke Road, Great Oxendon (Arthingworth Parish

The Parish Council object to this application for the following reasons:-

1) A decsion has already been made for an application on this site and it is very disappointing that a retropective applicacation should follow so quickly afterwards.

- 2) There are concerns regarding the increase of caravans in this rural setting.
- 3) This is contrary to Kettering Borough Council policy as they are trying to close the Greenfild site which is opposite. KBC planning officers have stated it is an unsuitable traveller's site a point echoed numerous time by the planning inspectorate when deciding appeals at Greenfields.
- 5) This site is unsustainable with no bus routes, single track roads and no shops or amenities within practical distance.
