



Notice of full road closure Stareton Lane and Stoneleigh Road, Stoneleigh

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

We will be carrying out BT diversion works and the installation of safety barriers adjacent to the carriageway.

To carry out these works safely, with minimal disruption the works and traffic management will be in phases as detailed below.

When will these works be taking place?

The works will be carried out in three phases, during the day between 9.30am-3.30pm, with no traffic management overnight or at weekends. The plant crossing on Stoneleigh Road will operate as normal until 6pm each day.

Phase 1: 11 to 15 September 2023

A full road closure of the new Stareton Lane with three-way temporary traffic lights on Stoneleigh Road. The diversion route for the closed Stareton Lane will be along Stoneleigh Road. Please refer to map 1.

Phase 2: 26 September

A full closure of Stoneleigh Road and Stareton Lane with a diversion along Leicester Lane. Access to Stoneleigh Park during this road closure will be from the Leamington side of Stoneleigh Road B4113. Please refer to map 2.

Phase 3: 16 to 27 October and 20 November to 1 December

A full closure of Stareton Lane with three-way temporary traffic lights on Stoneleigh Road. The diversion route for the closed Stareton Lane will be along Stoneleigh Road. Please refer to map 1.


Some disruption to travel times. Pedestrian and cyclist access will be maintained throughout the works



MAP 2 Phase 2, Stoneleigh Road and Stareton Lane closures




We would like to invite you to a HS2 drop-in session at The Kenilworth Centre.


