GLOUCESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, BOURTON-ON-THE-WATER) (COTSWOLD DISTRICT) (PROHIBITION OF PUBLIC SERVICE VEHICLES) ORDER 2012

The Gloucestershire County Council ("the Council") in exercise of its powers under Sections 1(1), 2 (1), (2), 4 and 19 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Traffic Commissioner in accordance with Part V of Schedule 9 to the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on the 5th day of July 2012 and may be cited as the "Gloucestershire County Council" (Various Roads, Bourton-on-the-Water) (Cotswold District) (Prohibition of Public Service Vehicles) Order 2012.
- 2. In this Order

"Public Service Vehicle" has the same meaning as Section 1 Public Passenger Vehicles Act 1981;

"Local Service" has the meaning given in section 2 of the Transport Act 1985;

"Local Bus" means a public service vehicle used for the provision of a local service not being an excursion or tour;

"School Bus" means a vehicle constructed or adapted to carry 12 or more passengers and being used to carry persons to or from a school

- No person except upon the direction or with the permission of a Police Officer in uniform or a Traffic Warden shall cause or permit a Public Service Vehicle to proceed at any time along the lengths of road described in the Schedule to this Order, in the Bourton-on-the-Water Parish in the Cotswold District in the County of Gloucestershire.
- 4 Nothing in Article 3 shall render it unlawful to cause or permit a Local Bus operating a Local Service to proceed along the lengths of road described in the Schedule to this Order
- Nothing in Article 3 shall render it unlawful to cause or permit a School Bus to proceed along the lengths of road described in the Schedule to this Order
- The "Gloucestershire County Council (Various Roads Bourton on the Water) (General Traffic Regulation) Order 2006 is hereby revoked
