#### 2 DECLARATIONS OF INTEREST

Councillor V Milner declared a personal interest in any matter arising on the agenda in relation to the Friends of Seamer Village, as she was Secretary of the Group. She also declared a personal interest in any matter arising on the agenda in relation to the proposed new housing development near Beacon Road as she lived in that area. Councillor D Raine declared a personal interest in any matter arising on the agenda in relation to the Friends of Seamer Village, as he was a member of the Group. Councillor Smith declared a personal interest in any matter arising on the agenda in relation to the Crossgates Community Centre as he was Chairman of the Association. Councillor J Ridsdale declared a personal interest in any matter arising on the agenda in relation to the proposed new housing development near Beacon Road as he lived in that area.

## 3 PUBLIC PARTICIPATION

The following matters were raised and discussed:

- Litter bins at The Green and the bus stop adjacent to the Crossgates Community Centre which required emptying
- Damage to a stile at Pasture Lane by a vehicle
- A hedge requiring cutting on the snicket between Napier Crescent and Lacey Avenue
- An overhanging tree on the highway at the Denison Avenue/Abbot's Garth junction
- The proposed housing development off Beacon Road
- A report from County Councillor Jeffels regarding white lining on Main Street, Seamer and the Horsefair

**RESOLVED** that

- (i) the litter bins be referred to the Borough Council
- (ii) the stile and hedge cutting be referred to the NYCC via County Councillor Jeffels
- (iii) the overhanging tree be referred to the NYCC via County Councillor Jeffels with a request that the Friends of Seamer Village Group be allowed to cut it back
- (iv) the points raised regarding the proposed housing development be incorporated in the Parish Council's comments to the Borough Council on the planning application

#### 4 PROPOSED HOUSING DEVELOPMENT OFF BEACON ROAD

The Council considered making comments on planning application 17/00452/FL for 241 dwellings with access, public open space and strategic landscaping on land to the north of Beacon Road, Seamer together with a letter from RESOLVE on behalf of Linden Homes regarding the proposed development.

RESOLVED that the following comments be made on the application:

- 1 The proposed new properties adjoining existing properties should be reduced in height due to overlooking
- The proposed new properties due to their intended density would result in the overdevelopment of and cramped feel to the site
- 3 Stoney Haggs Road should be substantially improved due to the large volumes of traffic resulting from the development
- The mini-roundabout on the B1261 should be significantly improved to cater for the large volumes of traffic which would arise from the development
- 5 The density of the proposed properties would result in an increased flood risk to the area from the site
- The legend on the site plan indicates sixty houses in the affordable bracket but there are only thirty-six shown on the plan
- 7 There may not be sufficient places available to cater for the children at local schools
- 8 There may not be enough NHS services to cater for the additional population from the site
- It is indicated that foul sewage would be disposed of via a mains sewer but there is no connection shown to the existing drainage system
- Any football field provided at the site will not be used by the school due to its distance from the school

- 11 The proposed footpath diversion would adversely affect existing residents
- 12 The new roadway should be increased in width to cater for parked vehicles
- The proposed development requires increased parking facilities to cater for new residents' vehicles
- At the presentation given in July 2016 it was stated that there would be a 'buffer' zone around the development this is not shown on the plan
- The farm track on the northern side of the proposed development should be designated as a formal public footpath
- The style of the proposed properties is not in keeping with adjoining existing properties
- 17 There should be increased diversity in the type of accommodation proposed to cater for retired people in addition to families
