

MINUTES OF THE MEETING OF OAKLEY & DEANE PARISH COUNCIL HELD ON SEPTEMBER 8TH 2022

Shortly before the meeting was opened it was announced that Queen Elizabeth II of England, after reigning 70 years, had passed on Thursday 8th September. Out of respect following this announcement, the Chair Mr. Harding made the decision to briefly open the Parish Council meeting to address <u>key business only</u> and then close it, as we entered the start of ten days national mourning.

Public Session

The Parish Council and public attending observed a moment of reflection to mourn the passing of Queen Elizabeth II. The minute's silence was held on Thursday evening at 19:30. As our new King Charles III ascends to the throne, the Chair Mr. Harding expressed that our condolences and thoughts were with the Royal family at this time, on behalf of the Parish Council; God save and bless the King.

The Parish Council and public attending then observed a second moment of reflection to mourn the passing of our Councillor Laurence Bealing, who sadly passed in late August following a period of ill health. The minute's silence was held on Thursday evening at 19:32. The Chair Mr. Harding expressed his condolences both personally and on behalf of the Parish Council to Mr Bealing's family.
