165 REPORT: ALLOTMENTS- Cllr Clements, Letheren

There was a report of a leaky tap in the allotments on Saturday 20th. The Clerk (RFO) attended and managed to stop the dripping tap, but there was still a leak underground. Cllrs Letheren, Clements, Clerks and Allotment Holders located a leaky joint below the tap and that was fixed on Sunday 21st. This recent discovery could have been the cause of an overly high water bill previously (£741)

Clerk RFO also reported that the gate at the entrance (main gate @ memorial hall) had stopped closing, concerns over who could get in there also- Cllr Clements along with some allotment holders managed to fix the bent hinge. Clerk RFO will source some spare/replacement hinges.

No principal concern but draw attention to encroachment in RAMSAR to rear.
- f. **MC/21/0445 Buddy's View Perry Hill Cliffe Rochester Medway ME3 7TX**
Change of use of land to provide for the stationing of 3no. additional caravans, extension of existing hardstanding and associated planting and parking-
After discussions this was deferred for more investigation by the Planning Committee and response submitted under the committee's delegated powers as it appeared the information was incomplete.
- g. **MC/21/0481 Orchard Bungalow Station Road Cliffe Rochester Medway ME3 7RU**
Proposal Construction of 1no. garage comprising 2no. parking spaces, garden machinery store and workshop plus first floor roof space for the purposes of storage and a home-office facility-
After discussions concerning the boundaries and building on open countryside, Cllr Harper proposed to raise concern about encroachment and seek clarification, seconded by Cllr Dibble- **14 AGREE, 1 ABSTENSION-MAJORITY DECISION.**
- h. **MC/21/0527 33 Swingate Avenue Cliffe Rochester Medway ME3 7QZ**
Proposal Construction of a first-floor side extension- Cllr Harper proposed no objections, seconded by Cllr Walton- **13 AGREE, 2 ABSTENSIONS- MAJORITY DECISION**

166.3 Other Planning Issues

- a) Hoo New Routes to Good Growth – consultation response to be submitted via planning chair-
The closing date for the consultation has now been pushed back. A response was sent on behalf of the parish council.
- b) Esquire potential development site (ZOOM meeting) – Response to be sent.
- c) Trenport (ZOOM meeting) – no specific details suggested by developer – possible reduction in size.
- d) Kent Rural Housing (ZOOM meeting) Clerk PO/Cllr Harper attended. Proposals for affordable housing for people with real local connection through Housing Trust – details to be investigated.

Clerk PO also mentioned another inquiry received late from a local shop keeper- there have been complaints regarding the noise of the chillers, which is a threat to the shop and possible closure. Cllr Etheridge offered to look into this with Medway Council.
