Fly-tipping - Ref 10874 - being investigated by TMBC and Sevenoaks District Council

Cherry Hay, Fairseat - garage with new access onto Byway

Thriftwood Camping and Caravan Park – alleged unauthorised works to form new hardstanding area and removal of trees (newly opened case)

106 a Bank Balances

107 **b** Accounts for payment

It was proposed by Cllr Bott, seconded by Cllr Sefer and agreed that the accounts for payment listed on Appendix A should be paid online. In addition, a payment to KALC for membership was authorised - £306.89

It was proposed by Cllr Bott, seconded by Cllr Sefer and agreed that an online payment made to the Copy Shoppe, West Malling, for £27.20 be ratified (for leaflets for house to house distribution by Cllr Tisson, re the proposed music events at Wings of the Morning field).

108 c Other Finance issues

No issues were raised.

- 7 WINGS OF THE MORNING FIELD licence application for music events / festivals Licence applications had been submitted by two events organisers:
- 109 **a The Swan, West Malling** –licence application for a marquee / music event to take place on bank holiday Monday 30th August

Following discussion it was agreed to object for the following reasons:

It is thought that the organisers are unsuitable applicants as in 2020 they had held a similar event that blatantly broke Covid regulations at the time, and was shut down, with the organisers receiving a fine. They have a blatant disregard for regulations. Objection would also made on the grounds of public nuisance, due to excessively loud music and traffic congestion. If TMBC are minded to grant a licence, the music should not exceed 65db. Local residents should be informed, and a contact phone number be provided and clearly displayed. All calls to be recorded.

- 110 **b BJP Productions Ltd (Matts BBQ)** premises licence application for up to three weekends per year between 1st April and 1st November, Friday Sunday, and bank holiday Mondays
- It was proposed by Cllr Bott, seconded by Cllr Falconer and agreed that planning barrister Jeremy Phillips QC from FTB be engaged to represent Stansted Parish Council at the Hearing, at a fixed cost of £6,000+VAT. Wrotham Parish Council had confirmed they wished to be involved and would contribute 50% of costs. Cllr Bott to liaise with Wrotham PC re our response.
- It was also agreed that Stansted PC would share costs with Wrotham PC to engage Highways Consultant Les Henry to produce a Traffic Report, highlighting the potential traffic problems. KCC Cllr Harry Rayner agreed to submit this report to KCC Highways, if the barrister agrees.

It was also agreed that a sound engineer should be engaged.

Borough Green PC had been invited to be involved; KCC Cllr Harry Rayner said that BG's main concern is inadequate train services, and that they would contact SouthEast Railways.

The licence Hearing to take place on 28th July at 10 a.m. and submissions to be received by Friday 16th July.
