 Two councillor vacancies may now be co-opted: Whilst some interest has been shown, no applications have been received to date. Councillors to seek completed applications.

98/21 Signage in the Village

Consideration to WTPC installing warning signage for deer and ducks (using powers to provide road traffic signs under the Road Traffic Regulations Act 1984):-

- One of the Deer Warning signs has been hit by an agricultural vehicle, twisting the sign inwards. NM will ask the Lengthsman to remedy (if he can work at heights) otherwise seek assistance from a volunteer in the community.
- Councillors to consider if an additional Deer Warning sign is needed (West Dean end) given the no. of deer incidents and threat to driver safety
- FC reported that she has acquired and donated temporary/mobile yellow Duck Warning signs which may be deployed as and where/when necessary. A member of the public reported a mother duck and her ducklings are currently along the Coach Road (stretch between Sopps Farm and Sopps Farm Cottage). FC to action putting out signs.

- missing caps on the Rec Grd play equip unable to source replacements that fit.
 NM will assist
- expressed her thanks to all those in the community who took part in the village clean-up. It was well attended by adults and children.
- expressed her thanks to Sara and Jamie Bowditch who cleaned the Pavilion
- Cllr Koetser has written to Thorngate Housing to report roof tiles falling on to the Rec Grd, presenting a H&S issue as it's near the play equipment
- FP3: after HCC refused the DMMO, FC submitted an appeal. HCC has now responded to that appeal and FC has in turn delivered her reply. Cllr Nick Adams-King is now involved and communicating with key parties e.g TVBC Planning Officer Paul Goodman. The matter is now with the Inspectorate to consider, the outcome being either 1) granted 2) not granted 3) a public enquiry
- has sent out to a number of landowners an HCC leaflet explaining landowners' responsibilities to clear footpaths on their land

LH

- has approached HCC Highways to resurface a section of the Dean Road
- is investigating use of the Riparian Responsibilities letter to write to landowners in association with HCC
- Norman Court has been approached regarding issue with Coopers Drove

ΚJ

- reported scalpings on the footpath (opposite Frenchmoor towards Bentley Wood) at Norman Court. FC has approached Norman Court and requested they clear – she will chase
- requested copies of FP maps. FC will provide once she has the licence no.

DH

- advertises jobs and discounts for family activities over WT Village FB. Now that the WT Village FB page is closed, she'll start to send to MC to publish on the website as well as the Village Newsletter
- will be tidying the War Memorial and carry out some planting shortly
