**6A New Road HP22 5JD**

*Two storey rear extension. Roof alterations to include dormers and roof lights.*

**ACPC: Object:** Overdevelopment of the existing dwelling which would dominate number 6 which is a historically significant building. The front facade is acceptable; if the rear gable was placed in line with the existing rear gable Council would reconsider their view.

**Bucks Council: Approved:** The proposed front and rear dormers would be confined within the edges of the host dwelling. It is therefore considered the proposed extensions would have an acceptable level of impact upon the amenities of these properties in terms of loss of light and overshadowing.

It will include the objections made to the withdrawn application 21/03557/APP and breaches of ACNP policies HQD1, B2, B3 and T1 and the intrusive nature of the proposals and increase in traffic and noise they will bring to the area. In addition, reference will be made to breaches of the VALP, NPPF, AONB and increased light pollution. Mention will be made to the current breach of condition 3 of planning application 17/A1603/DIS. **P21.139 Reports from Meetings**

- i. **Salvage Yard**  
A meeting had been held with the developers who had presented their design for the development at the site. The developers were informed that the site was outside the ACNP settlement boundary and the Parish Council would therefore not support any planning applications for the development of the sight.
- ii. **Woodlands, College Road North.**  
Cllr Read and Cllr Wyatt had attended the Bucks Council Strategic Sites Committee meeting where outline planning application 16/01040/AOP Woodlands was considered. Cllr Read had spoken outlining the views of the Parish Council. The committee would be recommending the approval of the outline application to the Director of Planning and Environment
