075/14	Oxfordshire Animal Sanctuary	<p>The meeting began with a brief presentation by John Lord representing the Animal Sanctuary. Debbie Heath (Chair) and Phoebe Stewart Cox (Marketing) were also present. John explained that the Sanctuary was the only 'non-destruction' sanctuary in Oxfordshire. He also noted that the recent Open Day held in August had been the most successful ever raising over £7,000. They thanked SPC for allowing car parking on the day and the whole village for their ongoing support and understanding.</p> <p>A question from the floor asked about the number of cats that were able to roam in the locality as there is concern about the deterioration of the local bird population. Debbie answered that the cats number about 60 (down from about 200) and that they are not allowed to roam free.</p>	For info.

The consultation feeds into the ongoing preparation of Local Transport Plan (LTP4) which will be presented for full consultation in the spring of 2015.</p> <p>SPC will request that OCC manage HGV lorry routes in the broad area from Wheatley to Henley more pro-actively through use of more weight limits, better signage and enforcement to limit traffic volumes as vehicles access the M40. 080/14	Crazy Bear update	<p>It was reported that the Crazy Bear were served a breach of building irregularities notice by SODC in early July. This follows the Noise Abatement notice (Section 80 of the Environmental Protection Act 1990) served by SODC earlier in 2014. The Crazy Bear have a period of time to respond so there was no further progress to report.</p> <p>It was reported that the Crazy Bear submitted a planning application as follows:-</p> <p>P14/S1429/FUL (Full) - Crazy Bear Farm, Stadhampton, OX44 7XJ. <i>Use of the site as an outdoor activity and rural pursuits centre with related educational activities, including the provision of a welcome and education centre; petting farm, course fishing ponds; a children's play and picnic area; multi-purpose animal shelters; toilet block; extension to farm shop to create tea room; conversion of building to gun and outdoor clothing shop; provision of temporary parking area and access thereto and associated landscaping.</i></p> <p>SPC replied by the deadline 14/8/14 and recommended REFUSAL. The full transcript giving material reasons for refusal is in the public domain and can be accessed through the SODC planning website. There were many other responses from local residents that can also be viewed. Lorraine Lindsay-Gale forwarded the following report:-</p> <p><u>Thriving Families Scheme</u> - national funding will allow OCC to begin working with more than 400 new families by the end of March 2015 and the Oxfordshire results will inform and influence the national scheme roll-out beginning April 2015.</p> <p><u>Road Projects</u> - notification that OCC are undertaking a number of major road projects. The 2 most likely to affect Stadhampton are:- Kennington / Hinksey Hill Roundabout - a £6m project to increase capacity by 30% in the evening peak period. The green will be protected with a five metre strip of plastic meshing through which grass can grow. Conversion of existing dwelling into two separate flats (one ground floor and one first floor), with proposed ground floor rear extension and new rear access. SPC recommended REFUSAL. SODC GRANTED planning permission on 16/7/14.</p> <p>P14/S1548/LDP (Certificate of Lawful Development) Elmbank, Thame Road, Stadhampton, OX44 7TX. Single storey extension at the rear - FOR INFORMATION ONLY. SODC GRANTED a Certificate of Lawful Development on 14/7/14.</p> <p>P14/S1573/HH - Ascott Paddocks, Ascott, OX44 7UH. Erection of a single storey side extension. SPC recommended APPROVAL. SODC GRANTED planning permission on 6/8/14.</p> <p>P14/S2501/PAR (Permitted Development Rights, Amended) Camoy's Farm, Chiselhampton, OX44 7UZ. Conversion of agricultural building to dwelling.
