New roadway, car parking areas and bike shelter to serve development on adjacent site.

The clerk has spoken to the planning officer and the reason this has been allowed to go to appeal is that the applicant was not answering gueries or giving the requested information necessary for making a decision.

The Parish Council strongly object to this application for the following reasons:-

- 1) The new roadway appears to be part of a haphazard development with a variety of applications and no masterplan.
- 2) There are several applications and developments relating to this site and it is unclear what this roadway will be serving and whether it is appropriate.
- 3) At present the roadway appears to lead nowhere and will be in the middle of a farmvard.
- 4) The bike shelter is totally out of character in the rural setting and would appear to be quite unnecessary considering the location.
- 5) Clirs. are confused and concerned about the proposed car parking spaces as it is unknown what they are servicing and why they are required.

Permission refused for the following reason:-

1) The design of the proposed development would appear incongruous with the surrounding area and would be out of character with the local village environment and would not sit comfortably within the immediate streetscene. The overtly modernistic form and appearance of the proposed dwelling would contrast with the existing buildings within the immediate vicinity, which include the early twentieth-century cottages to the west and the grade II listed Bosworth House to the north.

Other Planning Matters:-

1) Building between Siddoms Ford and Braybrooke Road

An email was received from a resident expressing concern about a construction being built at the above location. The clerk contacted DDC and it would appear to be a 'Permitted Development' – DA/2014/0084 – an agricultural building. The clerk to contact DDC Planning as the construction looks more like a house than a barn.

2) Permitted Development at Manor Farm

The clerk to check with DDC Planning whether permission is granted for 3 houses (PD/2016/0010) or 5 houses (PD/2018/0029) or 8 houses.

3) Wooden Structure in the grounds of Black Barn and the removal of trees covered by a TPO

A large wooden structure is being built in the grounds of the Black Barn

- 4) Potholes along Kelmarsh Road 931726 works have been instructed by highways inspector to be undertaken within 4 months COMPLETE

- 5) Dog bin on Oxendon Road not being emptied 2316977 / 101002316932. -COMPLETE
- 6) Trees in oxendon Road (from Arboretum attached to Old Manor) overhanging the road clerk to report
- 7) Lime tree on Kelmarsh Road is dead clerk to report
- 8) Pothole (previously filled) outside pub clerk to report
