**Emergency Planning** – Halo had agreed that Craven Arms Community Centre could be designated as a Emergency Centre in the case of an emergency and would produce an appropriate contact list should the centre need to be used. Cllr D Mills reported that Emergency Planning had been considered by the South Shropshire Association of Parish and Town Councils and it was anticipated that further guidance would be provided by Shropshire Council.

**Craven Arms Flood Alleviation Schemes**: Cllr D Evans reported that Shropshire Council were still in discussions concerning an appropriate scheme however this was depending on Funds being available. The Water Grills had been cleared along Corvedale Road and Lambeth Close following the recent heavy rainfalls.
