## Signs for the Village Green notice board are:

- 1. Dog walking Unruly/untrained dogs Users of VG and other dogs Put signs up indicating that dogs can run free, but owners should ensure they have control over them
- 2. Dog excrement Users of VG Signs indicating it is the responsibility of dog walkers to pick and remove any excrement (bin is available)
- 3. Tree Climbing Falling from a height Children and adults Introduce signs discouraging tree climbing and that doing so is at the risk of the individual.
- 4. Paddling in the Wallop Brook Sharp flints in stream. Danger to small unsupervised children of drowning Mainly Children and other users of VG to a lesser degree The stream is seldom more than 400mm deep although fast flowing. Children under 7 years need to be supervised if playing in the stream. Protective footwear is recommended for all.
- 5. No horses.
