Tree Preservation Order

TPO DA/473 2015

All Saints Churchyard

A TPO has been placed on the following trees: 1 Blue Cedar, 1 Sequoia, 3 Yews.

Note – this was following concerns (reported to DDC) over works carried out on a Yew tree in the churchyard. The Landscape Officer from DDC visited the site and determined that the works to the tree had not been completed and it had been left unbalanced with arbitrary pruning cuts made to the lower limbs. In the light of this and because works could be undertaken to other trees in the churchyard without permission it was recommended that a TPO be placed on five trees in order to safeguard their future.

Other Planning Matters:-

Old Red Lion Development (DA/2014/0109)

- a) Bus Stop From NCC A bus stop can be fixed to the brick shelter. Also a timetable case can be provided.
 - The clerk to confirm that this would be acceptable.
- b) Demarcation lines and stop sign at the end of the access road. No further news

Building works on Sibbertoft Road:- reply received from Bruce Allen (DDC) requesting more information. The clerk to write and supply.

Village Maintenance:-

Kelmarsh Road (just out of the village) – the drain under the road is blocked causing flooding. Highways are monitoring but to be reported as soon as there is a further problem.

Harb. Road (corner of Sibbertoft Road) – poor drainage with the verge continually flooded. Highways are monitoring – could be caused by a spring which may have been uncovered or some other ancient water course?

Naseby Road / Kelmarsh Road crossroads – flooding. Highways not aware of any problem but will monitor.

Bassett Way – weeds growing on the footpath – 704674 – Work instructed **Village footpaths** – weeds are growing through 706894 - Work Instructed

Sibbertoft / Marston Trussell Crossroads flooding becoming hazardous in icy weather. – 723731 From NCC – Site visited no C/way defects or flooding on inspection. Will continue to monitor location through highway safety inspections.

Light no 20, Kelmarsh Road not working. Reported

Blocked Drains – High Street, Gold Street, Harborough Road, Chapel Lane – 729955 **Longhold Road** – very dangerous potholes. 729951

Fly Tipping – household rubbish on the layby at the crossroads of Naseby Road and Longhold Road. – 101001984161

Junction of Longhold Road and Sibbertoft Road – a Stop sign and better road markings to be requested as soon as possible. This is an extremely dangerous junction and vehicles are often witnessed crossing the junction without stopping.- 729958

Reply from NCC: – After a Highways inspection the assessment is that no further signage is necessary and Highways cannot be responsible for poor driver behaviour. Cllr. Irving-Swift agrees it is a very dangerous junction and would like to arrange a meeting with a cllr. and lan Boyes from NCC to try and make some improvements. A meeting to be arranged with Cllr. Burnham.

Kelmarsh Road - The verges have been damaged due to the volume of traffic because of Naseby Road works. NCC (Paul Trowell, Highways) is aware and they will be reinstated

Naseby Road roadworks:- the clerk to report fly tipping and general mess.

Potholes:- Sibbertoft Road (between Chapel Land and Marston Gated Road Harborough Road (on entrance to village)

Re fly-tipping – the clerk to contact Cllr. Irving-Swift to ask if more secure recycling bins could be considered as a considerable amount of rubbish is generated in the village when they blow over.

Purchase of New Mower:-

It was proposed and seconded that a new mower be leased for a 48 month period. It was proposed and seconded that the clerk arrange the lease and the direct debit payments.
