01/21 Declarations of Interest:

Cllr D Evans declared a Personal Interest as Chairman of the Southern Area Planning Committee.

Cllr N Stephens – Grant application Craven Arms Youth Group.

02/21 Minutes:

The Town Council confirmed the minutes of the meeting held on the 25th May 2021.

03/21 Matter arising from the Minutes:

There were no matters arising from the minutes.

04/21 Chairman's Items:

The Chairman referred to the Police and Crime Commissioners Survey which he will complete on behalf of the Town Council

It is intended that a representative of the Police will attend future meetings when the Coronavirus restrictions have been lifted and produce a quarterly newsletter.

05/21 Highway/Street Lighting Items:

- a) The Clerk had ordered the replacement streetlight to be installed adjacent to 11 Onnybrook Drive Craven Arms.
- b) The Clerk had met several residents concerning the condition of the unadopted roadway in Brook Road and it was hoped to arrange a further meeting with Shropshire Council to discuss.
- c) Concern was expressed at the speeding of vehicles through Brookland Park and the Clerk would request that an appropriate speed survey be-undertaken.
- d) The Chairman, The Clerk and Cllr D Evans will be meeting with representatives of Highway England to discuss the speeding of vehicles along Shrewsbury Road as they enter Craven Arms both from the North and South and to enquire if speed monitoring signs could be provided. Following several complaints from local residents the local police had also agreed to undertake speed checks in the area.

06/21 Amenity Items:

- a) Craven Arms Playing Fields BMX Track—The Clerk reported that he had requested three quotes for the tarmacking of the BMX Track which would enable use by bikes, scooters, roller boots and skateboards. The Track had been installed in 2010 and although on the playing field was owned by the Town Council and until now had required little maintenance. It was anticipated that the cost of the works would be in the region of £15,000.
 - The Town Council agreed in principle to the work being undertaken subject to final confirmation at the next Town Council Meeting when appropriate cost will have been obtained and detail of the work to be provided. The Clerk would seek to obtain three quotes for the work.
- b) **Planters** The planters had been provided by Shrewsbury Town Council and had been installed by Graham Morris the cost of the planters this year would be meet from the Marches Coronavirus Fund.
- c) Gate Barrier Car Park/Picnic Area Corvedale Road Craven Arms Cllr A J Willets will make enquiries about the cost of a steel/iron metal barrier due to the constant damage to the existing wooden barrier.
