# CHIDEOCK PARISH COUNCIL

Minutes of the Parish Council Meeting held at the Village Hall, Chideock on Tuesday 27 September 2016 at 7:00 pm.

Present: Cllr Roger Carey (Chair), Cllr David Rogers (Vice Chair), Cllr Rob Murray, Cllr Geraghty

and Cllr Irena Campion.

**In attendance:** The Clerk, Cllr Christopher and 9 members of the public.

The Parish Council meeting commenced at 7.00 pm.

### 1858 Apologies.

Cllr Elliot sent his apologies which were accepted. Dorset County Cllr Turner sent his apologies.

PCSO had sent the following via e-mail at 6.28 pm:

"My apologies to the council, I had fully planned to attend this evening's meeting but have been delayed at a previous appointment and will now not be able to make it as I have a victim visit to complete before it gets too late.

I shall try to make it to the next meeting, commitments allowing."

- **1859** Grant of Dispensations. None.
- **Declarations of Defined Pecuniary Interests.** Cllr Rogers said he would take no part in Agenda Item 9A Planning Application WD/D/16/001744 as the site is adjacent to his property.

#### 1861 Minutes.

a) RESOLVED to accept and sign, as a true record, the minutes of the Parish Council meeting of 26 July 2016.

**b) RESOLVED** to accept and sign, as a true record, the minutes of the Planning Committee meeting of 22 August 2016.

Carried unanimously by all who were present at that meeting.

Standing Orders were suspended for the following item.

### 1862 Democratic Period.

Members of the public raised the following matters:

- The use of Gate Farm for the preparation and sale of food on the premises and that sale of alcohol and the current planning use of the premises
- The use of Mill Lane by large and wide HGVs proforma letters were passed to the Clerk
- A35 a request that meeting notes etc be made available **AGREED** that they will be **CC** put on the Chideock and Seatown website.
- A35 It is appreciated that the Parish Council is working on obtaining a low emission zone and safety improvements but what is happening in regard to obtaining a bypass? After discussion it was AGREED that the Parish Council is limited in what it can do and that a Chideock A35 Working Group should be formed within the village, in a similar manner to the Flood Management Group. The Clerk will advertise this and ask for volunteers

Cllr Geraghty reported that the A35 Miles Cross Working Group is working to improve how traffic is redirected when there is an incident on the A35.

Standing Orders were resumed.

### 1863 County and District Councillors' and Police Reports.

West Dorset Cllr Christopher reported as follows:-

- It has been a busy summer with many WDDC Planning Committee meetings and site visits.
- There West Dorset land supply required for the Local Plan has fallen below 5% which
  means that the Local Plan carries less weight in comparison to the National Planning
  Policy Framework.
- The potential changes to local government in Dorset and the possible creation of new Unitary authorities could impact land supply measurement and local plans – will this be on a District / Borough basis or across the whole county?
- National Park status for parts of Devon and Dorset is being promoted this could have significant impacts on development and infrastructure.
- Gate Farm Planning Enforcement should be contacted in regard to this matter.

**Item 19 – Gate Farm. AGREED** to write to Planning Enforcement querying the **CC** compatibility of current use of Gate Farm and the current permitted use category.

Item 19A – Inappropriate "advertising" signs at the junction of North Road / Main CC Street A35. AGREED to follow this up with St Giles PCC and the Weld Estate to ask again if they have any objections to these signs.

**Item 23 - 27 – Weight / width restrictions. AGREED** to query with Planning Enforcement whether the delivery of material by very large HGVs to Roadstead Farm via Mill Lane is in contravention of the planning use class.

# 1866 Planning Matters.

# a) Applications.

**WD/D/16/001744** LUSHAYS, BRIGHTHAY LANE Erection of timber Summerhouse in the existing rear garden of the Residential Dwelling (Full)

Chideock Parish Council objects to this application for the following reasons:-

- 1) Loss of neighbouring amenity due to proximity of the proposed development to the boundary of the neighbouring property (Orchard End).
- 2) Intrusion of privacy and denial of quiet enjoyment by the neighbour in their own garden resulting from use of the proposed building.
- 3) Excessive height leading to intrusion of privacy and loss of visual amenity to the neighbour
- Loss of screening by existing mature trees if cut down to give the excessive height proposed
- 5) The distance from the edge of the roof to the boundary is less than 1 metre so that the degree of intrusion is greater
- 6) The proposed development is in the previously undeveloped garden Should WDDC Planning decide to approve this application the Parish Council would like to see the following conditions:
- 1) Either the existing mature screening fir trees to be retained, or replacement planting to be evergreen trees of 1.5 metres minimum height

- 2) Development to be kept at least 2 metres from the boundary with Orchard End
- 3) No use for overnight accommodation or any commercial use.

Chideock Parish Council further suggests that WDDC Planning might consider recommending location of the proposed summerhouse further away from the boundary, and further north where the land appears to be lower.
