APM 005/18 ANNUAL REPORT FROM POLICE

A written report had been provided, as follows. Over the last 12 months, there have been 108 calls to Police regarding Atcham. The vast majority 57 are to report RTCs and highway incidents. Of the remainder many are non-crime incidents including reports of suspicious behaviour, dropped 999 calls and general information messages. Only 2 are to report theft related incidents specifically a shed break and theft of garden ornaments. There have been no dwelling burglaries, no offences associated with any of the licensed premises and the only offences of violence or threats are 4 reports of domestic violence or abuse. There has only been one vehicle crime reported at Attingham Park and upon viewing the report believe that to be more of a case of someone hitting a parked car and leaving the scene rather than a concerted effort to steal from within.

APM 006/18 ANNUAL REPORT FROM SHROPSHIRE COUNCILLOR

Shropshire Councillor Claire Wild had provided a written report. Adult Social Care increasing by £8 to £10 mil by year, ageing population and demographics. Ringway contract ending March 2018, then Kier take over and pot holes will be dealt with asap in April. Member of the public raised reduction in Central Government funding.

APM 007/18 CHAIR'S REPORT

2017/2018 - has been relatively uneventful, however, the main issues we considered have been:

The development at Salop Leisure. Love to Stay. Although hard to envisage from drawings and plans, the end result is quite remarkable, I wish Mark Bebb and his team success with this venture.

The problems associated with Emstrey Roundabout are still not resolved, Highways England clearly do not want to understand the issues I have brought to their attention.

APM 010/18 OTHER PARISH MATTERS

i) Grange Farm contractors speeding – request for signage erected on entry and exit from the farm to remind drivers to calm speeds

Alistair has spoken to them about speeding before – will do so again and will try to organise signage.

ii) Grange Farm contractors (gardening contractors) fires

Has got waste exemption for burning green waste and wood. Was not there on day it happened but put fire out as soon as was aware and has told contractor not to burn unless he is there.

iii) Malthouse Lane-deposits of mud and dirt from farm vehicles & request for dedicated road sweeper where needed

His farm contracting operation now at main base in Cross Houses but can't control the landlord's contractors. Try to use alternative access via fields when weather makes it possible to. Write to Longnor estates – via Balfours – Alistair to arrange a meeting with managing agent.

iv) St. Eata's Lane fence

Previous investigation suggested the fence was put by the developer but the company in longer in business – it is often the norm for such fences to be maintained by residents after erection. It was suggested that perhaps residents need to sort it out jointly as it is not the council's responsibility.

v) Malthouse Lane and roads and pavements into Mytton and Mermaid - poor state of repair and pooling of rain

Cllr. Wild reported that this is in the works programme but timescale is not known. Pavements and road condition to be reported to Colin Blower and the owner of the Mytton and Mermaid.

vi) Atcham bridge surface and condition of posts entering the bridge

Raise with English Heritage.

vii) Dog fouling

Signs have gone up.

viii) Concerns re speeding – raised option of CSW.

Residents are asking for a speed limit review. The chairman suggested that the community write to the parish council so a request can then be made to the police to review.

ix) Neighbourhood Development Plan

A resident of Cross Houses, who is suggesting a NDP is done covering Cross Houses and surrounding parishes, claims £500k from Weeping Cross in CIL – this may be 25% if a NDP or 15% without. He felt the community should be involved and was asking the PC to have a vote on whether to do a NDP. Noted.
