## M3 SERVICE AREA PROTEST

Maria Miller Mp has launched a parliamentary petition to demonstrate residents' concerns about new motorway service area proposals A planning application for the proposed MSA at J6 Black Dam is currently being considered by BDBC. A proposal for Hatch Warren has not yet been submitted to planning but a second

round of developer-led public consultation is expected in the next few months. Significant environmental and road traffic concerns have been raised regarding both proposed developments.

Maria said: 'Tens of £millions of taxpayers' money has been spent to improve our roads, and our sewage works have been upgraded to cope with new housing. All the improvements are put in jeopardy by these two commercial proposals, which were not called for in our Local Plan.

'I would encourage all those who wish to register their concern about new motorway service areas to sign the petition and ask any friends, family and neighbours also to sign. The more signatures I get, the greater the impact of the petition, which I will then present formally in Parliament.'

Regarding the proposed MSA at Junction 6, Ward Cllr Onnalee Cubitt said: "Basingstoke residents say our stretch of the M3 has enough excellent 24-hour motorway services already in between Junction 4 and 5 at Fleet and between 8 and 9 near Winchester. This proposal is a risk to our historic environment and treasured landscape. Basingstoke residents don't want 24-hour blots on our local landscape polluting our nights, our air and our water." Kate Tuck, Chairman of SOLVE said; "No to Moto. No to damaging the River Loddon. Moto's proposed service station is next to important chalk fed springs of the River Loddon"

Declares that that urgent action must be taken concerning proposals for new Motorway Service Areas at Basingstoke; further that there is no need for any additional motorway service areas given that the existing services at Fleet and Winchester are only 23 miles apart; further that the development of any new facilities will be detrimental to the environment and traffic congestion; further that they are clearly not in the best interests of Basingstoke residents; and further that the two proposals that have been made to date, one at Junction 6 and one near Junction 7 are not acceptable

The petitioners therefore request that the House of Commons urges HM Government to ensure that road safety and the avoidance of traffic congestion are given priority over any unnecessary new motorway service areas around Basingstoke; and further urges the Department of Transport to reinstate the requirement for there to be a minimum distance between motorway service areas.



#### POLICE UPDATE

**Dear Residents** 

During the early hours of Friday March 2nd during the snow, two sheds was broken into at a house on Newnham Lane at the Old Basing end of Newnham village. Several items of garden machinery were stolen.

On March 22nd at 9.40 am a resident from Tunworth Road, Mapledurwell, came home and found a white Transit van with MAYERS CLEANING SERVICES written on the bonnet parked in the driveway, it is suspected the two men described as you, white, one being 5'4''/5'5'' tall, stocky build, clean shaven, were involved in the theft of up to £500 worth of metal from the garden. The price of scrap metal has risen recently and we have seen an increase in theft of metal across the area.

Please also be aware of an increase in theft from parked vehicles, in the Lychpit / Old Basing area of Basingstoke fourteen vehicles were broken into or tampered with in an attempt to break into them within 30 days, please do not leave valuables in your vehicle, if it is a works van please park as close to another vehicle / wall to prevent access to the rear doors. On a similar note as the evenings become lighter for longer may I remind anyone visiting the rural area's to go on walks not to leave ANY valuable's including handbags etc. or mobile electrical item such as laptops etc. in their cars, each year car parked in isolated rural beauty spots will be targeted and valuables stolen, thieves are also using wireless technology to located equipment.

Also BT are offering a free service to combat nuisance calls, PPI, accident claims etc. it diverts nuisance calls to a new junk voicemail which you can access by calling, for more information please call 0800.328 1572 or visit bt.com/callprotect.

Please also be aware that predominately at this time of year we see an increase in garden sheds being broken into and the theft of garden tools, machinery. Please consider a shed alarm which are not too expensive, likewise please record the serial numbers of equipment and mark them in some way perhaps etch on your post code, also please consider a photograph as we do on occasion get stolen property back but do not know who the owner is.

## Mapledurwell and Up Nately Parish Housing Needs Questionnaire 2018

The Parish Council has received a request from Radian Housing Association to carry out a survey, at their expense, into the housing needs of Mapledurwell and Up Nately Parish.

They are working with Savills plc - a global real estate services provider - who has commissioned Chameleon Consultancy to undertake the survey. The stated aim is to establish the possible need for more 'Affordable Housing' within the Parish.

The Parish has no Neighbourhood Plan and this not considered to be appropriate for our current needs. However, when the subject of housing is formally discussed, it is vital that the views of all residents are properly understood and taken into consideration.

With this in mind the Parish Council has agreed to support the survey.





## **WARD BOUNDARY REVIEW**

The Local Government Boundary Commission for England is responsible for reviewing local authority electoral arrangements, defining boundaries for local elections and the number of Councillors to be elected, as well

as conducting reviews of councils' external boundaries.

The Ward Boundary review aims to provide 'electoral equality', that is, each councillor representing approximately the same number of electors. Community identity and interests, and facilitating effective local government are also considered.

### This phase of the consultation is open to 7th May

The Commission will publish its draft recommendations in August and then open a further phase of public consultation. New Wards are scheduled to come into effect at the 2019 council elections.

Note that this Electoral Review of BDBC is a separate undertaking from the review of parliamentary constituency boundaries carried out by a separate body (Boundary Commission for England).

The Local Government Boundary **Commission is recommending 54 Ward Councillors compared to the** 60 at present for Basingstoke and **Deane. Basing Ward currently has** three Ward Councillors represently roughly the optimum number of electors. Newnham Parish Council will be responding with its view that the Basing Ward should remain unchanged.

### NATIONAL PLANNING POLICY FRAMEWORK consultation

The National Planning Policy Framework (NPPF) sets out the Government's planning policies for England and how these are applied. The 'Framework' must be taken into account in the preparation of Local and Neighbourhood plans, and is a Material Consideration in planning decisions.

The Prime Minister launched the consultation draft of the updated NPPF on 5th March.

This revised Draft incorporates policy proposals previously consulted on in the Housing White Paper; 'Planning & Affordable Housing for Build-to-Rent', and 'Planning for the Right Homes in the Right Places'.

Proposals within the latter for calculating housing need are important for the Submission Hart Local Plan as they support lower housing figures for Hart.

But the same centrally imposed calculation method increases the present BDBC figure of 850 dwellings per annum and this is likely to manifest itself in the Local Plan five-year review. Land put forward in the 2017 'Call for Sites' is presently being assessed.

The consultation documents are supported by draft Planning Policy Guidance on Viability, Housing Delivery, Local Housing Need Assessment, Neighbourhood Plans, Plan-making and Build to rent.



PROTECTING ANCIENT WOODLAND

Revised wording in the Draft NPPF increases planning protection for ancient woodland, but this has not been extended to provide stronger protection for individual ancient trees

Para 118 in Chapt 11 'Conserving and Enhancing the Natural Environment' (the 'para 118 loophole') previously said:

• planning permission should be refused for development resulting in the loss or deterioration of irreplaceable habitats, including ancient woodland and the loss of aged or veteran trees found outside ancient woodland, unless the need for, and benefits of, the development in that location clearly outweigh the loss;

The revised draft (now Para 173c) says 173. When determining planning applications, local planning authorities should apply the following principles:

c. development resulting in the loss or deterioration of irreplaceable habitats (such as ancient woodland) should be refused, unless there are wholly exceptional reasons and a suitable mitigation strategy exists. Where development would involve the loss of individual aged or veteran trees that lie outside ancient woodland, it should be refused unless the need for, and benefits of, development in that location would clearly outweigh the loss;' ...

It's important to note that 'wholly exceptional' would allow for Nationally Significant Infrastructure Projects (NSIPs) but these schemes are assessed outside the NPPF directly by the Planning Inspectorate. (HS2 is being decided by an act of parliament.)

#### The Woodland Trust says

'The proposed change of wording will provide greater clarity for local planning authorities, encourage high quality, sustainable design and – by heading off inappropriate applications and subsequent legal challenges and campaigns against them – will speed up decision-making and save resources. It's crucial that the Government sees public support for this during the consultation period. The proposals to improve protection for ancient woodland must remain in the final draft of the new NPPF. The proposal to detach aged and veteran trees from ancient woodland and downgrade these irreplaceable habitats must be rejected.'



### Letter from Reverend Linda Scard

On a recent trip to Liverpool – my first – Lewis and I visited the two cathedrals in the city. Entering both was a "wow" moment but they couldn't be more different. As I walked around I couldn't help but think of all those college assignments which





Liverpool's Anglican cathedral is the biggest church in England - St Paul's would fit inside with space to spare — and it has the world's largest tower and the longest footprint after St Peter's in Rome. Only Seville cathedral outranks it in gothic volume. The first thing that strikes you is its vast size and space. Begun in 1904 and not finished until 1978, there had been much debate over its style. Committee minutes report a view that "gothic architecture produced a more devotional effect upon the mind than any other which human skill had invented". Others regarded gothic as a "worn-out flirtation in antiquarianism, now relegated to the limbo of art delusions." In the end it was the 22 year old Giles Gilbert Scott, grandson of the great Sir George, whose gothic design was allowed to go ahead.

In stark contrast, and looking slightly odd and out of place under the Great West Window are the words "I felt you and I knew you loved me" in pink neon graffiti by Tracey Emin (of "unmade bed" fame).

Work started with the Lady Chapel and this was consecrated in 1910. All around the chapel the words to psalm 98 – O sing to the Lord a new song - are engraved alongside 48 angels, each with a different musical instrument, some just singing. One stood out – the angel holding a football rattle. Well, this is Liverpool! When I enquired whether the angel (or Giles Gilbert Scott) was a red or a blue, I was told he was definitely a red!

After a few minutes' walk down Hope Street, Liverpool's Roman Catholic cathedral comes into view. It's known locally as "Paddy's wigwam" because of its inverted funnel shape, crowned by a spiky coronet. Built on the site of the city's obsolete workhouse, this cathedral was consecrated in 1967, when the Anglican cathedral was still 11 years off completion. The Second Vatican Council (1962-65) pronounced that the altar should face the congregation and allow worship "in the round", and this is the case here. 2,000 seats are arranged in a circle, so all eyes are focused on the raised central altar. The atmosphere is quite subdued, except for the blue light caught from the Reyntien's stained glass coming down through the central flue right onto the altar in the middle of this vast space. Very special.

#### Which did I prefer? Both!

Buildings are important, but Paul reminds us that it is we who are "members of the household of God, built upon the foundation of the apostles and the prophets, with Christ Jesus himself as the cornerstone. In him the whole structure is joined together and grows into a holy temple in the Lord; in whom you also are built together spiritually into a dwelling place for God." (Ephesians 2: 19-22)
