a) MC/22/2480 - Land at Town Road Cliffe Woods Rochester Medway ME3 8JL

Application for a non-material amendment to planning permission MC/21/1287 to replace the formerly proposed pond with a mini orchard comprising of 4 cherry trees and 5 apple trees Comment: None

b) MC/22/2438 - 43 North Road Cliffe Rochester Medway ME3 7UH

Construction of a single storey wrap around extension - demolition of existing garage.

Comment sent prior: The Parish Council would want to ensure that adequate on-site parking remains to be provided as the site is adjacent to the hammer-head at the end of North Road.

c) MC/22/2329 - St Helens Cottages 1 Buttway Lane Cliffe Rochester Medway ME3 7QT

Construction of a single storey and basement extension to rear.

Comment sent prior: The Parish Council, as the neighbouring land owner of The Buttway, has the following observations/queries: The proposal is to excavate to form the basement. There is no specific reason given for this. There has been archaeological investigations very close to the site in recent years (pre covid). How will access to the site for excavation and soil removal be arranged (bearing in mind Parish Council's ownership)? What is the purpose of the extension element outside of the main building curtilage?

- a) Trenport Land, Cliffe Outline planning application for access has been refused by Medway Planning, planning appeal expected. Refusal decision notice not yet published.
- b) MC/21/1287 Redrow (Gladmans) site west of Town Road Planning application approved, site issues and development concerns continue to be raised with Medway Council. S278 Highways Design issues being followed up, including potential road closure/diversions.
- c) Esquire MC/21/1694 (Orchard) south of View Road Although approved decision notice has not yet been published.
- d) 2 Tennyson Avenue Reported to Medway Council (Planning Enforcement).
- e) Draft Local Plan Medway are now planning to return to Regulation 18 which will delay the plan until early 2025.
