3385/21 To receive and accept apologies for absence

Apologies received from Cllr O'Brien. Cllr May proposed to approve the apologies and the reasons; this was seconded by Cllr Saville and resolved by the Council – 6 votes.

To say a few words in memorial of Kath Fish and to hold a minutes silence

The Chair read a few words in remembrance of Cllr Kath Fish; following with a minutes silence. The speech is recorded at the end of the minutes.

3387/21 To receive and record declaration of interests from Members in any item on the agenda

No declaration of interests received.

3388/21 To suspend the meeting to hold a 10 minute public session

The Chair suspended the meeting to open the public session. No members of the public asked any questions. The meeting was then convened to carry out with the Council meeting.

3389/21 To receive reports from the District & County Councillors

District Cllr Kevin Dukes sent his apologies.

County Cllr Kevin Greaves gave his County Council report as follows:

- Work on the grips on Jockey Lane are in the work programme to be done shortly
- The Bridge is causing concern over the drop on the road; this is a Highways England issue and Highways are liaising with them to get a date for the works to be carried out
- Last week there was a Communities and Places Committee meeting at County; two items on the agenda he would like to bring up:
- 1) Report on the Highways Asset Management at County; one item mentioned relating to the review for repairs, maintenance or improvement of pathways and cycle ways. The review was to ensure is the above work is proportionate to the amount of pedestrians/cyclist that can be reasonable expected to use them, the review will be completed in March. Cllr Greaves abstained from this vote because these works are quite relative to parishes and small villages. As we know, pathways do get overgrown with weeds and moss etc., and often have to be dug out. The report is saying that if the paths are not used often, they will not be repaired. Cllr Greaves questioned who is it that is saying that they are not being used enough?
- 2) Highways trees and verge maintenance some years ago Cllr Greaves started a pilot scheme in planting wild flowers on verges to encourage insects and wild life. This scheme was put on hold for some time but now the County Council are looking at

starting this again with approximately 24 sites. If the Parish Council knows of any sites that would benefit from wild flowers; then please put this forward to the County Council. There is also 150 Highways trees to be planted; particularly in areas to mitigate flooding.

At this point the Chair thanked Brendan Clarke-Smith MP for attending the meeting. The MP then thanked everyone for their part during Covid 19; next week Government will release a road map of coming out of the restrictions. Yesterday there was an announcement about more money for roads and pavements; plus the upgrading of the A&E at the hospital.

The Clerk reported that the District Council has confirmed that the Parish Council can now co-opt a new Councillor onto the Parish Council. The Clerk will put together a notice ready to advertise the vacancy with a dead line of the next meeting.

3397/21 To consider and approve the budget for 2021/22

After consideration, Cllr May proposed to approve the budget for 2021/22; this was seconded by Cllr Savill and resolved by the Council – 6 votes.

The expenditure budget is £20,070.00; the estimated income (if no change in precept) is £14,926; the short fall will be used from the general reserves if required.

3398/21 To consider and approve the precept for 2021/22

After consideration, Cllr Davis proposed to increase the precept by 1% to £13,917.00 giving an additional income of £138.00; this was seconded by Cllr Roberts and resolved by the Council – 6 votes.

The impact on the residents will be £56.98; an annual increase of 0.15p per Band D property.

To consider proposal by the Tuxford under 13's Youth Football Club to use the sports field for their home matches

The Chair reported on the above proposal which is subject to the approval of the Football Association. After the Chair's report and confirmation that the benches are to be reinstated; Cllr Roberts proposed to approve the request from the Tuxford Under 13's Youth Football Club to use the sports field; this was seconded by Cllr Davis and resolved by 6 votes.

3400/21 To receive reports and consideration of any expenses on the following:

1) Sports field & play area safety inspections

- Cllr O'Brien has carried out the last sports field inspection; no actions reported
- Cllr May reported that the mole catcher has returned and removed the traps
- The contractor will be resurfacing the little BMX track; plus looking at the big BMX to suggest what can be done with it.
- Cllr Roberts reported someone on facebook has reported a broken bottle on the field; Cllr May will deal with this.
- The Chair also reported that another football club called the Misfits United; has
 contacted the Council showing some interest in the football pitch in the next
 year or so; following his discussion with them; he has passed them on to liaise
 with the Tuxford Football Club

2) Cemetery

- All is okay with the exception that some graves stones need attention due to movement. Cllr May has spoken with Cllr Stronach and he will be looking at who is next of kin and contacting them.
- It was also noted that a notice board would be useful in the cemetery to show the rules and regulations etc. This was put forward for the next agenda.

3) Defibrillator inspections

• Cllr Savill reported that the defibrillators were okay; however replacement batteries would be required shortly; Cllr May proposed to purchase replacement batteries when required; this was seconded by Cllr Roberts and resolved by the Council – 6 votes.

4) Highways and service faults

- The Chair reported that the resident who is donating trees and bushes for planting on the highway has purchased 34 fruit trees 16 fruit bushes. The plan is to start planting them this afternoon while the weather is good
- The Chair reported that he saw someone measuring up on the bridge and stopped to speak with him. It was a Foreman carrying out an assessment for the work to be carried out; hopefully in the next couple of weeks (if the current weather doesn't hold them up). They are looking to resurface 9 metres on the carriageway across the bridge and resurface the hump in the road
- The Clerk reported that Cllr O'Brien has reported the fly tipping on Cross Lane
