<p>1) Development proposals should identify significant map) which are locally valued and which make an important contribution to the neighbourhood area’s landscape character.</p>	<p>[insert map of views to be protected; appendix to contain the photographs and the descriptions of views (see importance)]</p>
<p>2) Where a development proposal impacts on an identified significant view, a Landscape and Visual Impact Assessment (LVIA) or similar study should be carried out to ensure that the landscape is not compromised.</p>
