# DODDINGTON PARISH COUNCIL

Minutes of the Parish Council Meeting held in Doddington Village Hall on Monday 13 September 2021

Also present were the High Sheriff of Kent Mr John Weir, County Councillor Rich Lehmann and seventeen members of the public.

Cllr Coates welcomed every to the meeting.

The meeting was adjourned for the presentation of the KALC Community Award to Pam Cowan by The High Sheriff. The presentation was followed by light refreshments.

7.45pm the meeting was resumed.

#### 1. APOLOGIES

All Members were present.

Apologies had been received from Ward Member David Simmons

#### 2. DECLARATIONS OF INTEREST

Cllr Attwood declared a pecuniary interest in item 9.i. a neighbouring property and also in 9. iv.

# 3. TO DETERMINE WHETHER ANY ITEMS SHOULD BE DISCUSSED IN CLOSED SESSION

None were identified.

#### 4. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 12 JULY 2021

It was **AGREED UNANIMOUSLY** to accept the minutes as a true record of the meeting. Cllr Coates duly signed the minutes as a true record.

# 5. MATTERS ARISING

Road signs not removed

Cllr Coates reported that Alan Blackburn, KCC Highways, had been contacted about the removal of road signs after completion of work, he has requested the location of signs left behind.

Cllr Jones said this can be reported via the KCC Highways portal.

Cllr Cuthbert said it is an issue as it affects the hospitality trade in the village as guests have to take a detour unnecessarily.

# Sycamores at Sunnyside

Cllr Coates informed Members that the sycamores at Sunnyside had been reported to Optivo who said it was not their land. The land is the responsibility of Swale Borough Council and has been reported but there has been no response.

ACTION: Clerk to chase.

#### Fence at Sunnyside

Cllr Coates said the issue of the fence at Sunnyside has been raised and the matter is waiting for an appeal meeting, the Review Panel will make a site visit on 28 September with a decision by 5 October. The Council continues to be supportive of the resident.

ACTION: Cllr Fraser to attend the meeting.

#### Land near Sunnyside

Cllr Coates reported the Clerk had contacted the owner of the land near Sunnyside, no response has been received.

Cllr Fraser informed Members that the vegetation has been tidied but the fencing has not been put together again properly and is falling down.

ACTION: Clerk to thank owner for help and request the fencing be re-instated safely.

#### 6. NEIGHBOURHOOD WATCH REPORT

Sally Mills, the Neighbourhood Watch coordinator was unable to attend but had submitted a report, the contents of which were noted.

Councillor Coates thanked Ms Mills for her report and her ongoing work in support of Neighbourhood Watch.

Councillors were concerned to hear that GPS receivers and computers were stolen from farm vehicles at Down Court Farm.

# 7. PUBLIC QUESTION TIME

No matters were raised.

#### 8. HIGHWAYS

## i. To receive an update

Cllr Fraser raised concern about the pothole repair at the junction of the Old Lenham Road and also other potholes along The Street which are a hazard to cyclists.

Cllr Coates said the priority is to get The Street resurfaced.

ACTION: Clerk to contact Alan Blackburn, KCC Highways, to remind him that in 2016 he had said the road would need surface dressing within the next two or three years to waterproof it and keep it sound.

#### ii. HGVs

Cllr Coates thanked Cllr Cuthbert, Cllr Fraser and the Clerk for attending a meeting with Sarah-Jayne Ellcock.

Cllr Cuthbert reported that initially Sarah-Jayne Ellcock mentioned the Council's complaint and said that more work needed to be done to look at alternative routes for lorries. The meeting discussed Lorry Watch; enforcement from the Police; the Police and Crime Commissioner be contacted for assistance. KCCllr Shellina Prendergast said the HGV signs has been a waste of money. The meeting did not address the issues which Doddington has. There was a concern that if a weight restriction were imposed that it would displace the lorries.

Cllr Fraser said the meeting should have been limited to the Parish Council's concerns and the local parishes, there were attendees from a wider area. Selling and the A251 were also discussed. If a weight restriction were imposed, it would be difficult for lorries to use other narrow rural lanes. The A251 and A249 is where HGVs should be.

KCCllr Lehmann said that Lynsted with Kingsdown Parish Council was unaware of the meeting. Cllr Coates said the issue is important to residents and there is strong support from Lynsted with Kingsdown Parish Council and Wychling Parish. Goodwin's lorries are coming through regularly and others including Lime Logistics. He also said that it looked as though the above meeting had been side-tracked and that the issue for the Parish Council,

with Lynsted and Wychling was relatively straightforward. Will KCC Highways support our application for a 7.5 tonne weight limit with exemptions for local businesses?

KCCllr Lehmann said he was now fully sighted on the issues and will contact Sarah-Jayne Ellcock.

# iii. Drainage and Flooding

Cllr Jones reported that KCC's consultants had provided an initial report on how flooding can be alleviated through expanding the capacity of the Kings Acre lagoon. Their assessment was that an expansion would only be of marginal benefit KCC have asked the consultants to assess other options to manage flood risk as well.

Cllr Attwood said other areas to consider could include woodlands on the east of the Old Lenham Road and near the pumping station to the west but these may not be practical. Cllr Jones said work was scheduled to fix the drain blockage from Sunnyside to the garage.

Cllr Coates thanked Cllr Jones for his report and thanked Cllr Attwood for his support.

#### 9. PLANNING MATTERS

#### i. Ref: 21/504637/TCA

Address: Yew Tree House The Street Doddington Sittingbourne Kent ME9 0BH

Proposal: Conservation Area Notification for 1 x (T1) Lawson Cypress - Fell.

The Council had not been formally consulted on the application. Councillors agreed not to comment on the proposal.

# iii. Ref: 21/504300/FULL

Address: Hill Top Farm Elverland Lane. Ospringe Faversham Kent ME13 0SP

<u>Proposal: Demolition of existing stables. Erection of new stables and kennels including a dedicated tack room, feed room, toilet and welfare facilities (Part Retrospective).</u>

The Council had not been formally consulted on the application. Councillors noted the proposal.

Cllr Attwood left the meeting and took no part in the discussion or decision on the next planning applications.

#### iii. Ref: 21/504433/LAWPRO

Address: 1 Down Court Cottages Down Court Road Doddington Sittingbourne ME9 0AT Proposal: Lawful Development Certificate for proposed external alterations to flank and rear elevations to enlarge window and door opening and provide entrance canopy. Erection of two bay cart lodge.

The Council had not been formally consulted on the application. Councillors noted the proposal.

# iv. Ref: 21/503914/EIOUT & 21/503906/EIOUT

Address: Land To The West Of Teynham London Road Teynham Kent

Proposal: Outline application with all matters reserved for the phased development of up to 95.51 hectares of land comprising: demolition and relocation of existing farmyard and workers cottages, up to 1,250 residential dwellings including sheltered/extra care accommodation (Use Class C2 and Use Class C3) - up to 2,200 sq.m/1 hectare of commercial floorspace (Use Class E(g)) - mixed use local centre and neighbourhood facilities including commercial, business and employment floorspace (Use Class E), non-residential institutions (Use Class F1) and local community uses (Use Class F2) floorspace, and Public Houses (Sui Generis) - learning institutions including a primary school (Use Class F1(a)) - open space, green infrastructure, woodland, and community and sports provision (Use Class F2(c)) - highways and infrastructure works including the completion of a Northern Relief Road, Bapchild Section, and new vehicular access points to the existing network - associated groundworks, engineering, utilities, and demolition works.

The Council has not been consulted on this but can comment if Councillors so wish

The Council had not been formally consulted on the outline application but had been advised of the proposal by the developer. Councillors considered the proposal and raised concern about the impact of the development on the village and the surrounding lanes; there would be an increase of traffic during the building and then afterwards; there have been no improvement to the A2; there is no route for the northern relief road; Southern Water does not have the capacity for the sewerage; the infrastructure is insufficient for the development. Councillors **AGREED UNANIMOUSLY** to object to the proposal.
