20.08 THRIVE Housing Association

Cllr Tubb reported that members of the Parish Council attended a meeting at the Parish Council offices with residents, 2 members of the police, Local District Councillor Carole Paternoster and the new Local MP. Notes of the meeting had been circulated. It was clear from the meeting that the party mainly to blame was the housing association, Thrive, their processes on how they appoint tenants and lack of follow up. Previous meetings with Thrive had involved a very junior member of staff who had since resigned. It was now apparent that there should be a meeting at a senior level with Thrive. The 4 members of the planning committee at tonight's meeting were at that meeting. It was AGREED that a letter should be written to include the following
