#### PUBLIC PARTICIPATION

A member of the public spoke against application WD/2021/1689/F Little Harness Farm. He stated a letter of objection had already been submitted to WDC and to the Clerk for circulation. He believed it was not normally necessary to supply accommodation to agricultural workers. An

undetailed business plan had been submitted with only basic figures supplied and he felt there was not a sufficient case for its justification. The design was inappropriate in an AONB and the location of the proposal was 13ft from the boundary of his property. The size of the building and the roofline were extremely detrimental to his property. He suggested the council should object to the application in its entirety. He finished by stating the applicants had had several applications in the past and the conditions set by WDC had not always been met.

Another member of the public agreed with these sentiments and added the plans submitted were inaccurate and inconsistent.

Cllr Wells left the meeting at 18.38.
