DODDINGTON PARISH COUNCIL

Minutes of the Parish Council Meeting held at Doddington Village Hall on Monday 9 December 2019

Present: Cllr Kevin Attwood (Chairman), Cllr Steve Coates (Vice Chairman), Cllr Graham Cuthbert, Cllr Peter Duckworth, Cllr Kevin Fraser, Cllr Colin Jones and Cllr Alison Shaw; and Mrs Wendy Licence (Clerk)

1. APOLOGIES

All Members were present.

Apologies had been received from County Councillor Andrew Bowles (at another meeting); apology noted.

2. DECLARATIONS OF INTEREST

None were declared.

3. TO DETERMINE WHETHER ANY ITEMS SHOULD BE DISCUSSED IN CLOSED SESSION

None were identified.

4. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 11 NOVEMBER 2019 It was AGREED UNANIMOUSLY to accept the minutes as a true record of the meeting. Cllr Attwood duly signed the minutes of the meeting.

5. MATTERS ARISING

Cllr Attwood reported that a second letter had been sent to the owner of the Land on The Street, there has been no response.

Cllr Duckworth said the matter could be considered at the next meeting.

Cllr Attwood said Lenham Storage has responded that they have briefed their HGV drivers not to use Faversham Road as a route between the Faversham area and back to the depot. They will continue to monitor the data they receive from their own fleet and advise drivers accordingly. Their drivers are instructed not to use their own navigation systems. Cllr Jones said the company should be thanked for its response and the invitation to send registration numbers of their fleet.

Cllr Fraser said the problem is not with the Lenham Storage fleet but with its suppliers and subcontractors, signage in different languages could be put up at the depot.

ACTION: Clerk to thank Lenham Storage for its response and request that notices in foreign languages be put up at the depot to inform suppliers and sub contractors of the request.

Cllr Attwood informed Members that survey strips on the road towards Newnham are nothing to do with Newnham Parish Council and the survey is possibly being carried out by a developer.

6. COMMUNITY WARDEN REPORT

Community Warden Dave Osborne was unable to attend the meeting but had highlighted the latest scams and reported the following incidents:

Between 4 and 4:30am on 9 November, criminal damage was caused to property belonging to Southern Water, in Eastling Road Eastling Faversham.

Between 21 and 28 November, all four tyres were slashed with a Stanley knife in Sunnyside, The Street Doddington Sittingbourne.

9. WAR MEMORIAL

Cllr Attwood said concerns had been raised about volunteers working on the banks near the War Memorial. The War Memorial Risk Assessment states that volunteers should not be on the bank if the ground is unsuitable and that a car should be parked on the road at the base of the steps and cones be placed in the road either side of the car to indicate to traffic that there is a potential hazard.

Councillors considered a request for heavy wire strands to be stretched across the bottom of the banks as a safety grab stopping people working on them ending in the road, but it was felt that this could cause harm and that there is an alternative safety measure.

12. DEFIBRILATOR

Cllr Coates reported that there were no issues with the defibrillator and the pads will need to be replaced within the next three months.

13. SPEED WATCH

Cllr Fraser reported that the Speed Watch sessions continue in the village. A motor bike has been recorded on several occasions speeding through the village, the motorcyclist has received two Police notifications and is now under investigation.

14. PLAYING FIELD

i. Cllr Duckworth's monthly report

Cllr Attwood said the play area inspection will take place on 16 December.

Cllr Duckworth reported the nothing of any significance came down during recent high winds. The grass has grown but it will have to wait until the ground improves before the grass can be cut.

Cllr Fraser reported that there had been reports of a rough sleeper at the top of the playing field

Cllr Shaw said the appropriate charities should be informed.

ACTION: Cllr Shaw to send details of charities to the Clerk.

ii. To consider quotations to fell sycamore tree

Cllr Duckworth said he had met a contractor to give a quote to fell the tree.

Cllr Attwood said five contractors have been contacted and only two quotes have been received so far.

ACTION: Clerk to contact contractors again for a quote and seek further quote.

iii. To consider quotation to cut the Playing Field

It was **AGREED UNANIMOUSLY** to accept the quotation from Landscape Services for £345.26 for thirteen cuts of the Playing Field.

15. HIGHWAYS

Cllr Duckworth reported a series of eight-wheeled trucks had been going through the village every day.

Cllr Fraser said the lorries are tipping what they are carrying at Tonge Farm Golf Club and using the valley road through Doddington, Lynsted and Teynham.
