16/347 Apologies : A Price, P Hooper

16/348 Declarations of Interests: None declared

16/349 Comments from the Public – Two members of the public spoke in relation to the Agenda item 16/44 – DA/2018/0560 Land at Corner of Naseby Road and Gold Street – construction of 9 dwellings – application for appeal – on behalf of an action group which represented ten residents of neighbouring properties. They had employed the services of a planning consultant who had made the following comments in relation to the appeal:-

.

- There are no new advancements on the original application
- The critical need for housing is not substantiated and no reference is made to the findings in the Neighbourhood Development Plan
- The reference to NPPF policy R1 with regards to the lack of recreational space is not substantiated.
- The statement regarding the current site not being beneficial to the village is in conflict with the tree preservation order currently in place in that it is an important open space.
- The impact on the neighbouring Grade 2 Listed property has not been considered fully. '

NDP fees – The Clerk reported that the current grant allocation had been spent in relation to the Neighbourhood Plan, but that confirmation had been received from Your Locale that further grant funding could be obtained.

Mower Lease – End of Lease term discussion - It was **RESOLVED** to continue with the Mower for a further year at the sum of £120 per annum.

DA/2018/0560 – Land at Corner of Naseby Road and Gold Street – Construction of 9

dwellings – Application for appeal – It was **RESOLVED** to **OBJECT** to the appeal on the following basis:-

'The objection e mails dated 2nd August and 23rd October 2018 still apply in full (subject to point 2):-

- 2. It should be noted that further to numbered point 7.2 of the PC letter of objection of 2nd
 August 2018, the progress of the Neighbourhood Development Plan
 ('the Plan') is well advanced namely:
 - 2.1 A draft Plan has been prepared and circulated to all members of the Plan committee:
 - 2.2 Strategic Site Assessments ("SSAs") have been carried out for prospective development sites for the village;
 - 2.3 As a result of the SSAs a proposed allocated site for 10 dwellings (4 affordable houses and 6 market value houses) has been agreed by the Plan committee, negotiations are proceeding with the landowner, and also with the relevant housing association who would manage the 4 affordable housing units; and
 - 2.4 the proposed allocated site does not breach any TPOs, does not use up any important open space relevant to the form and character of the village, and does not impact upon the setting of any listed buildings.

We emphasise that section 5.37 of the Appellant's Appeal Statement of February 2019 is misleading when it states that "...much of the proposed development is located..." outside the Village Design Statement designated open space. The majority of the square footage of the dwellings proposed to be built lie within the designated open space.

Clipston Parish Council therefore does not support this application.

DA/2019/0179 – Carport to front of dwelling at Hillside Kelmarsh Road – It was **RESOLVED** to **OBJECT** to the application for the following reason :The proposed development is not in keeping with the existing buildings and would detract from the appearance of the street scene.
