Section 3 – External Auditor Report and Certificate 2017/18

1 Respective responsibilities of the body and the auditor

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention the lack of Risk Assessment carried out in the year 2017/18. In our view Section 1, assertion 5 should have been answered 'no'. The internal auditor has indicated that the smaller authority has since taken the necessary action by performing a risk assessment in May 2018.
