MBC Strategic Planning and Infrastructure (SPI) Committee Meetings

The SPI meeting was held on 4th October 2021 when MBC's Review of Local Plan was discussed. After discussion of several proposed amendments this was put forward to MBC Full Council meeting on 6th October. At this meeting it was agreed that the Local Plan would go to Regulation 19 and the consultation period would be from 29th October to 12th December. Cllrs agreed to discuss their response to Regulation 19 at the Planning Committee meetings on 2nd November and 16th November. There will be an Extra Ordinary Full Council Meeting on 7th December to have a final sign-off of the response.
