- c) Cllr Horwell to contact Lucy Ireland, local Footpath Warden.

# 08/05/23 General Power of Competence

The General Power of Competence (GPC) came into force through the Localism Act 2011 as part of the Government's move towards the decentralisation of powers down to town and parish councils. GPC gives local councils the power to do anything that individuals generally may do as long as it is legal.

To be eligible to act under GPC a council must pass a resolution at which time at least two thirds of the members must hold office as a result of being elected and the Clerk must hold the Certificate in Local Council Administration (CiLCA).

Resolved that the Parish Council met the eligibility criteria for the General Power of Competence.

# 11/05/23 Reports from Councillor Representatives

### Recreation Ground / Open Green Spaces

Verges within the 20mph limit are due to be cut at the end of May.

Two bags of stone chippings have been spread along the edge of the Gold Street slip road to minimise muddy conditions. This action was approved by OCC Highways.

Planters have been replanted with new plants by Carol Turner who has offered to maintain the planters on behalf of the Council.

A new single slab has been placed inside the pedestrian gateway to the recreation ground. Further slabs have been placed in front of the gate to the play area.

The owner of the pathway alongside the church has given permission for the Council to lay bark chippings along the pathway.

Resolved to purchase a tonne bag of bark chippings.

#### Playground

Following a report of bees nesting, the play area has been checked but no evidence found.

It is proposed to replace the small bin in the MUGA, which fills up quickly and is not easy to empty, with one of the blue bins originally located at the entrance of the play area.

# **Utilities and Highways**

Orders for pothole repairs have been raised on Fix My Street but OCC has a backlog of work.

Thames Water carried out CCTV investigation work on 8th April and concluded there are no operating problems related to the pumping station.

### 11/05/23 Correspondence

Great Haseley Horticultural Society have submitted a request to use the recreation ground for overflow parking on Saturday 26th August 2023, the Society will provide stewards. **Resolved** to allow parking on the recreation ground on 26<sup>th</sup> August 2023.
