# 16 To discuss and agree the next step to move forward the proposal for traffic calming on Firswood Road

It was agreed to pause the proposed plan to install bollards on Old Engine Lane until the full extent of work to be completed by Wain Homes and Bellway is established.

# 17 Report from South Lathom Residents' Association (SLRA) for information only

Complaints had been made about road works on Firswood Road which had not been managed by LCC. SLRA will take up the issue with LCC. There had been no advance notice of the road works to residents. It was questioned if the road should have been closed for the work to be completed safely. It was noted that contractors working in the road are only able to go as far as the end of the 30mph section and then they are required to reapply for permission to continue into the 60mph section of the road.
