Minutes of the Elkesley Parish Council meeting held on Tuesday 19th June 2018, at 7.00pm in the Elkesley Memorial Hall, High Street, Elkesley.

Present: Cllr Ffoulkes-Jones, Cllr Fish, Cllr Flear, Cllr May, Cllr O'Brien, Cllr Stronach & Cllr Woodcock Others present: Mrs Davies (Clerk), County Cllr Kevin Greaves and members of the public.

2998/18 Election of Vice-Chair and receive Declaration of Acceptance of Office

Cllr Fish proposed Cllr O'Brien for the Vice-Chair for 2018/19; this was seconded by Cllr Flear and resolved by the Council.

2999/18 To receive apologies for absence

Apologies received and approved for Cllr Oldbury and Cllr Wilkinson.

3000/18 To receive and record declaration of interests from Members in any item to be discussed

No Declaration of Interests received.

3001/18 To suspend the meeting to hold a 10 minute public session

The meeting was suspended and the issues raised were:

- Query over the minutes for proposing the Memorial Hall representative
- No item in the Idle Times Cllr on holiday
- Speed signs for High Street
- Suggestion to have a contractor cutting the sports field again agenda item for the next meeting

3002/18 To receive reports from the District and County Councillors

District Cllr Kevin Dukes sent his apologies.

County Cllr Kevin Greaves gave the following report:

- The Notts County Council has approved the application to add a public bridleway along Battery Lane to the Definitive Map. Clarification was sought from Cllr Greaves by members that this is only the start of the progress and the lane remains <u>not</u> a public right of way until or if the lane gets put on the Definitive map and the removal of the gate will only occur when this progress has been concluded; this was confirmed by Cllr Greaves
- Cllr May asked Cllr Greaves if 'slow down' speed signs could be erected in the village

3003/18 To approve the minutes of the meeting held 15th May 2018

Cllr Woodcock proposed to accept the minutes of the meeting held 15th May 2018 as a true record; this was seconded by Cllr Flear and resolved by 7 votes.

3004/18 Planning – To consider any planning applications, note any planning correspondence and decision notices

Application: 18/00623/FUL

Location: Manor Farm, Twyford Lane, Elkesley Proposal: Conversion of a single storey barn to provide a new dwelling and the construction of four other new dwellings There were concerns over the access which the Highways will consider; however no reasons for the Parish Council to object.

Cllr Flear left the meeting during this agenda item for a few minutes. Cllr Woodcock proposed not to make any objections; this was seconded by Cllr May and resolved by the Council.

Application: 18/00739/HSE

Location: Cotswold, High Street, Elkesley Erect a two storey side extension and minor remodelling to existing dwelling Proposal: Cllr Stronach proposed not to make any objections; this was seconded by Cllr O'Brien and resolved by the Council by 7 votes.

3005/18 Finance – To approve payments and receive financial update

The Clerk circulated copies of the May finances and bank statements for the Councillors to view. The Chair proposed to approve the following payments; this was seconded by Cllr May and resolved by 7 votes.

3006/18 To consider in principle the maximum amount to be awarded in any small community grant given and to consider the Community Small Grant Policy

Copy of the draft grant policy had been previously circulated for the Councillors to consider; after discussion, Cllr O'Brien proposed to approve the Small Community Grant Policy with the maximum grant amount set at £50.00; this was seconded by Cllr May and resolved by 7 votes.

3007/18 To consider the "Heads of Terms" for the management of the garages on behalf of the village

Copy of the Head of Terms for the management of the A1 garages had been circulated previously for the Councillors to consider. After discussion, Cllr O'Brien proposed to accept the Head of Terms; this was seconded by Cllr Fish and resolved by 7 votes.

3008/18 To receive village reports on the following:

Sports field and play area inspections

Cllr May reported that the independent play area inspection has been carried out and the report has been received. All the items were classed as low or very low risks with some items requiring attention which will be dealt with.

Highways and service faults

The telephone number to report any potholes or highway issues has been put in the Idle Times for residents to use; the Chair has reported the potholes she has seen. The Chair and County Councillor Greaves will chase up the repair to the damaged road name sign for the Elkesley Bridge Road. Cllr Woodcock reported that Highways will be tarmacking the damaged side on Lawnwood Avenue.

Cemetery

Cllr Fish reported there was no water in the cemetery; it appears that someone has left the tap open and all the water drained out. Cllr Ffoulkes-Jones has moved the water container to nearer the front wall to save any damage to the grass and graves whilst he is moving it to be refilled with water. Cllr Flear proposed that Cllr Ffoulkes-Jones is reimbursed for the water at £5 per refill; previously £20 Cllr Fish approved the proposal – payment approval at the next meeting.

Defibrillator inspection

Cllr May has removed some graffiti on the defibrillator cover.

Allotments - no updates received.

3009/18 To receive any updates on the 100yr of WW1 Commemoration project

Due to the little time left to do something; Cllr Ffoulkes-Jones will talk to the new Vicar about her ideas and if see if we can do something together

3010/18 To receive reports from any meetings attended by Parish Council representatives

- Cllr Stronach reported that the Memorial Hall meeting had been cancelled so he had not been able to attend.

3012/18 To exclude members of the public under the Public Bodies (Admission to Meetings) Act 1960 to discuss staff hours

At this point members of the public left the meeting.

Cllr May left the meeting towards the end of this agenda item.

After discussion with the Clerk; Cllr Ffoulkes-Jones proposed that the clerk's unpaid hours from the last six months are spread over the next 7 months wages and that any extra hours should be paid in the month they are worked; this was seconded by Cllr Flear and resolved by the Council 6 votes.

Following discussion regarding litter picking on the sports field; Cllr May reported that the Street Cleaner has been told not to do any litter picking (Cllrs to do) and to empty the bins every two weeks; the grass cutting is a priority at this point in time.
