Thank you for your email below in relation to the above application.

In relation to the actual mining operations at the site, we have no further comments to make on the proposal provided the operations are carried out strictly in accordance with the application details provided.

Discussions have been taking place between the developer and Network Rail regarding concerns we have over the proposed route of site traffic, which incorporates the railway level crossing at Springs Road in Misson (Beech Hill Crossing) and we expect that this discussion continues in order to satisfy us that the crossing will not be adversely affected by site traffic. We therefore require a condition that stipulates that suitable mitigation measures (and the relevant Asset Protection Agreements) must be in place to protect railway assets prior to work commencing on site and that any damage caused by site traffic will be rectified by the developer.

I trust full cognisance will be taken in respect of these comments. If you have any further queries or require clarification of any aspects, please do not hesitate to contact myself I would also be grateful if you could inform me of the outcome of this application, forwarding a copy of the Decision Notice to me in due course.
