19.87 WELCOME & APOLOGIES

19.88 PUBLIC SESSION

Eighteen Red Kites seen in field behind Vicarage Lane – noted don't take live pray.

19.89 MINUTES OF PREVIOUS MEETING of 15th July agreed and signed.

19.90 DECLARATIONS OF INTEREST in items on the Agenda – none.

19.91 WHITEWATER VALLEY PRESERVATION SOCIETY

Representing the Whitewater Valley Preservation Society (WVPS), Tom Ryder-Runton said all Whitewater Parishes are now members – a win-win situation to have input and support from the Parish Councils and be able in turn to feed information back to the community.

Salmon and Trout Conservation tested the Whitewater in May and found phosphate level too high. Salmon and Trout Conservation are a national charity campaigning for wild fish and their environment. They work to influence government policy, industrial practice and individual behaviour to improve the river environment. A majority of rivers are failing water quality tests and more rigorous testing and controls are needed. The catchment of the Whitewater is predominantly agricultural – Defra's approach is to engage with and advise farmers.

19.92 HIGHWAYS

i SID Update See **APPENDIX I** for July data.

Suggestions put forward for

- Fixed County-installed speed indicator signs
- Police speed camera road signs
- Traffic islands – two near West Green turning – where recent accident – and one at Hound Green near original site of phone box.

Noted that most dangerous section of road is where Police speed camera van waits – but speeds here of necessity are comparatively low.

ii HCC / Parishes meeting – HCC 'Highways' officers not available for September meeting. In general they are available for advice or for meeting re specific proposals – but not regular meetings with all Parishes.

iii Culverts

1. Brook culvert Adam Knight reported Highways' contractors to have jettied the pipes through The Meet (blocked due to roadside culvert grate being removed) and put a camera into the Brook culvert under the road. The camera revealed another two-inch pipe jointing the culvert at the point it enters the pipe into The Meet. Contractors unable to investigate further as this not included in their work-sheet – they indicated that they would report back to Highways Engineer who would take appropriate action.

Contractors also noted four inches to a foot of silt in the ditch through Lanterns, accumulated since cleared by PGGM on 28th January this year. Ongoing regular clearing work needed.

2. Exploratory jetting at Hound Green – Awaiting report.

iv Lengthsman tasks

1. Footpaths have been strimmed at Glebe Wood and West End Farm.
2. Further work required on FP 16 where hedgerow encroaching. Noted that 'to keep back overgrowth from the side or above' is the duty of the landowner.
3. Bottle Lane – Reminder – Lengthsman to contact re ditching work.

v Bottle Lane No information from HCC re reason for advertised road closures.

vi Potholes should be logged on Hantsweb (advise from Cllr Simpson).

vii Footpath maps Hants definitive map not yet updated to include the new bridleways confirmed and signed on Hazeley Heath.

vii Hazeley Bottom – white post-and rail

Discussion

- Hazeley Bottom resident reported the length of white post-and-single-rail adjacent to the Parish noticeboard is in need of maintenance, some rails and posts rotten, one rail fallen (missing). Requested it be maintained as a feature of the Village.
- The post-and-rail is on Common Land now owned by RSPB, erected by previous owner, previously maintained by neighbour now moved away.
- RSPB permission needed to undertake work on their land .
- Parish Council has a role in supporting community – to seek the majority view in Hazeley Bottom.

ACTION To contact residents and RSPB.

viii Footpath repairs / maintenance

Repairs needed to bridge on FP 21 near Alder Moor Farm logged on HCC website.

Also noted that bridge at Diple Mill in need of repair.

Overhanging hedgerow FP 16 – from Mattingley Green end by Windrige Farm.

19.94 HOUND GREEN

i Bus shelter

Merronbrook will move the former bus shelter through 180 degrees to face the Green. This is likely to be within the next month when they make a timber frame delivery locally – and so will have the necessary crane and equipment in the vicinity. If they can provide a photo it can be included with an article and 'thank you' in the *Whitewater Magazine*.

ii Phone box base

Confirmed location near to site of former bus shelter by the ditch crossing to Hound Green Close **APPENDIX II**. A new base will be needed as per spec provided by Bob Aylmer. Estimate for £450 received so far.

PCSOs will not be available for remaining 2019 Parish Council dates.





APPENDIX IV – PLANNING UPDATE 19TH AUGUST 2019

19/01861/TPO (Validated 16 Aug 2019) Land At Japonica, Hound Green, Mattingley. Oak (T1) (1) Remove two branches vertically overhanging two LPG gas tanks supplying the property (2) Remove one branch that immediately overhangs the cable running from the B3349 road entrance telegraph pole to garage apex at front of property.

19/01542/CA (**Approved** 14th August) Mattingley Green Cottage, Mattingley Green. T1 - Fell one dying Liquid Amber T2 - Lift lower limbs from Liquid Amber by shortening lower limbs by a max of 1-1.5m T3 - Crown thin Hazel stool by coppicing selected stem T4 - Shorten lower limbs of Red Oak up to a height of 4.5m and by 1-1.5m T5 - Crown lift Ash to approx 4.5m. *Parish Council response: no objection.*

19/01505/HOU and 19/01506/LBC (Validated 11 July) Hazeley Bottom Farm, Hazeley Bottom. Relocation of entrance gate *Parish Council response: no objection.*

19/01431/HOU (Validated 02 July) Old Forge, Hazeley Bottom. Erection of a single storey sun room to side, demolition of existing single storey sun room to side, erection of a two storey side extension and two first floor side extensions, insert one window into east elevation at first floor and replace flat roof with pitched roof. *Parish Council response: No objection. Noted that a similar application was recently withdrawn and bat surveys undertaken.*

19/01389/FUL (Validated 26 June) Lynchmere Cottage [land adjacent to], Reading Road, Mattingley Erection of a two storey, two bedroomed dwelling and associated garage, access and landscaping following demolition of the existing barn and greenhouse. *Parish Council response: Mattingley Parish Council recognises that the proposed dwelling is just outside the settlement boundary, but also that prior approval has been received for the barn conversion. No other parties are affected and the Parish Council has no specific objection to the alternative application.*

19/01236/TPO (**Split decision** 22nd July- **mostly refused**. Mattingley Lodge, Reading Road, Mattingley. I am requesting approval to trim back 4 x Oak trees. 3 of these Oak trees (T1,T2 & T3) I would like a crown reduction reducing the tree to about 60% of its current spread due to heavy shading and low hanging branches. The 4th tree (marked T4 and circled in red) overhangs heavily onto our property and is about 1 metre away from fouling on the roof of the garage. The health of this 4th tree is in question due to the heavy vines which are taking over - I would therefore advise that someone takes a look a close look. I would like a crown reduction on this tree (T4) back to a level whereby it does not encroach onto our land, an estimated 50% of it's current spread. *PC Response: 'Mattingley Parish Council is mindful of the importance of native trees in the environment and landscape, and believes strongly that the protection afforded by TPOs should be respected. The Parish Council would defer to the Tree Officer regarding any work that may be necessary to secure the health and future of the TPO Oaks subject to this application.'*

Split decision and REFUSES PERMISSION for the following works: - T1, T2 and T3 - Oaks - crown reduction to 60% of its current spread. - T4 - Oak - crown reduction to 50% of its current spread. 'REASON FOR REFUSAL: 1. The 4 x mature oaks are in good physiological health and are prominent when viewed from the Reading Road. They offer significant benefits in terms of public amenity and the proposed reductions are far in excess of that which is recommended within the British Standards (BS3998:2010). Crown reduction to this extent would have severe impacts to the physiological condition of the trees and their value to public, visual amenity. Shading is not considered to be sufficient reason to carry out such works to high amenity trees. 'The Council GRANTS PERMISSION for the following works: - T4 - Oak - 2 metre reduction from the fabric of the building (garage)'

19/00955/FUL (**Refused** 'Decline to Entertain' 6th August) Alder Moor Farm Reading Road Heckfield Hook RG27 0LB Application for change of use of agricultural land and buildings to equestrian use (retrospective) and siting of a mobile home for an equestrian worker.

19/01165/HOU (**Granted** 25th July) Fox Glade, Hazeley Bottom. Erection of a first floor to convert bungalow to two storey dwelling, erection of a single storey side extension following demolition of conservatory and alterations to fenestration. Remodelling of property including ground floor extensions and first floor accommodation. *Parish Council comment – No objection.*
