- 1) Welcome by Chairman: The Chairman welcomed all to the meeting
- **2) Present:** Councillor C Wild- Chairman Councillor H Roberts-Vice chairman Councillor C Bonsey Councillor M Howorth Councillor R Ward Councillor R Purslow Councillor S Hawksworth:

3) Helen Howie from Berry's and Clive Benfield from Fletcher Homes: Discussion and feedback on the master plan for Holcroft Way as circulated in the Village Pump on Phase 1 Reserved Matters and Phase 2 outline application on development on 2nd part of the site with new access road and new roundabout. Helen presented the proposals for phase 1 and phase 2 of the development. Phase 1 includes upgrading the belisha beacons and installing VAS at each end of the village.

The intention is to submit an outline application for Phase 2 of the development before the reserved matters for Phase 1 is submitted as the new roundabout is part of Phase 2, however it is a very expensive part of the development and there will need to be some houses on phse1 sold to finance this part of the project. There will be an outline application submitted following this meeting with an indicative layout shown.

The full presentation to be sent to the clerk for the parish records. Helen requested that all those present complete a feedback form and these responses would be taken back and collated and there would be further consultation with the Parish Council and Shropshire Council. Members of the public asked many questions and Helen & Clive left the meeting at 8.45 pm along with the members of the public.
